Driver 2 stated that she had finished backing, was in the lane of travel, and was starting to move forward as vehicle 1 backed into her vehicle.

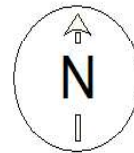
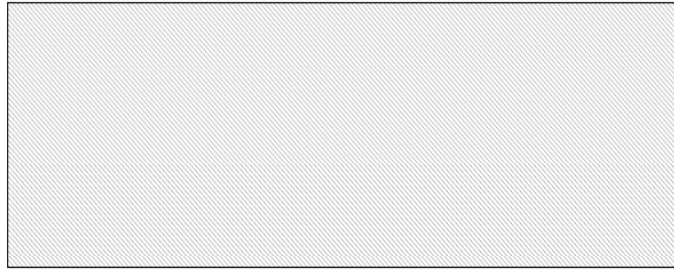

Motor Vehicle Crash Diagram

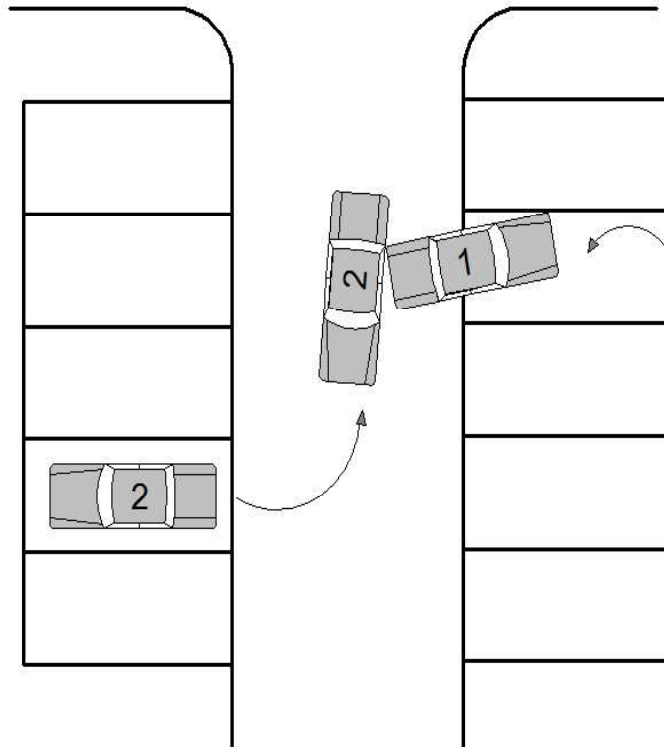
