135 Crash Description

Vehicle 2 was parked in a parking space in front of 1930 Route 88 facing southbound. Vehicle 1 attempted to park in the parking space directly behind Vehicle 2. While Vehicle 1 was in the process of parking, Vehicle 1's front bumper struck Vehicle 2's rear bumper.

Vehicle 2 was unoccupied at the time of the crash. The driver who parked Vehicle 2 (Christina Gazia-Seymour) advised me she parked the vehicle on May 03, 2015 at approximately 0855 hours. When she returned to her vehicle later in the day at 1540 hours, she observed Vehicle 1's front license plate resting on her rear bumper. Gazia-Seymour pulled her vehicle forward and realized she had two small punctures from the license front license plate of Vehicle 1.

While I was on scene, the Driver of Vehicle 1 returned to his vehicle. Driver Vehicle 1 did not notice he struck Vehicle 2. Driver Vehicle 1 stated he parked the vehicle on May 03, 2015 at approximately 1230 hours. He advised me he had two passengers in the vehicle.

No injuries reported on scene.

Vehicle 1 sustained no visible damage.

Vehicle 2 sustained minor damage to the rear bumper.

Driver Vehicle 1 was issued summons 39:3-36 1506 E15-3825 (Failure to advise DMV of address change).
