Vehicle 2 traveling westbound on Route 88 close to the entrance to the Walmart located at 1872 Route 88. Vehicle 1 traveling eastbound on Route 88 in the same area. Vehicle 1 then begins to make a left turn into the Walmart entrance and enters into Vehicle 2's lane of travel. Vehicle 2 is unable to come to a stop to avoid a collision with Vehicle 1. Vehicle 2 crashes into Vehicle 1.

Based on my investigation and observations on scene I determined Vehicle 1 to be at fault for the motor vehicle crash.
