135 Crash Description

Crash occurred in the parking lot of Walmart, located at 1872 RT 88.

Driver #2 stated she was traveling west in the parking lot of Walmart when she was subsequently struck by vehicle #1, which backed out of a parking space into her vehicle.

Driver #1 stated she checked her mirrors as well as her back up camera and did not see anyone coming. She advised she began backing out and was struck by vehicle #2.

All occupants of both vehicles advised they were not injured.

Based on the evidence presented to me, driver #2 had the right of way as she traveled in the main aisle; therefore Driver #1 is at fault for failing to yield right of way to vehicle #2 as she began backing out of the parking space.

It should be noted that I made contact with the store security in an attempt to review the surveillance footage of the crash. The security officer attempted to locate the crash on film, but couldn't, due to a defective camera.
