135 Crash Description

Vehicle 2 was parked in the parking lot of Walmart located at 1872 RT 88. When the driver came back outside after being inside approximately 10 minutes, he found damage to the left rear corner of the vehicle to include the fender and rear quarter-panel. The damage was significant, but the vehicle was able to be driven. The driver was unable to recall the description of the vehicle that was parked next to him.

Vehicle 1 left the scene immediately after the accident, and did not provide any information before the driver of Vehicle 2 came out of the store.

A check of the store's surveillance camera footage was not able to reach the area of the parking lot where the crash occurred. At this time, there are no suspects and no known witnesses.
