135 Crash Description

Vehicles 1 and 2 were located in the parking lot of the Provident Bank at 1930 RT 88. Vehicles 1 and 2 were parked next to each other, with Vehicle 1 parked to the right of Vehicle 2.

Vehicle 1 began to back out of its parking spot, as Vehicle 2 remained parked with its occupant in the driver's seat (Karen Salmon). While attempting to back out of the parking space, Vehicle 1 came into contact with the rear right corner of Vehicle 2. Damage was extremely light and barely visible on both vehicles. It was very difficult for reporting Officer to observe the damaged area.

Both vehicles were able to be driven from the scene, and no motor vehicle summonses were issued.
