Vehicle 1 was making a left turn out of the parking lot, from 1608/1610 Route 88. Vehicle 1 was intending to head onto Route 88 east. Vehicle 2 was traveling east on Route 88, in the same area. Vehicle 1 turned directly into the path of Vehicle 2. Vehicle 1 struck Vehicle 2, causing damage. No injuries were reported on location. Driver 1 stated she did not observe Vehicle 1 in the travel lane, prior to the crash. Driver 2 confirmed the above sequence of events.

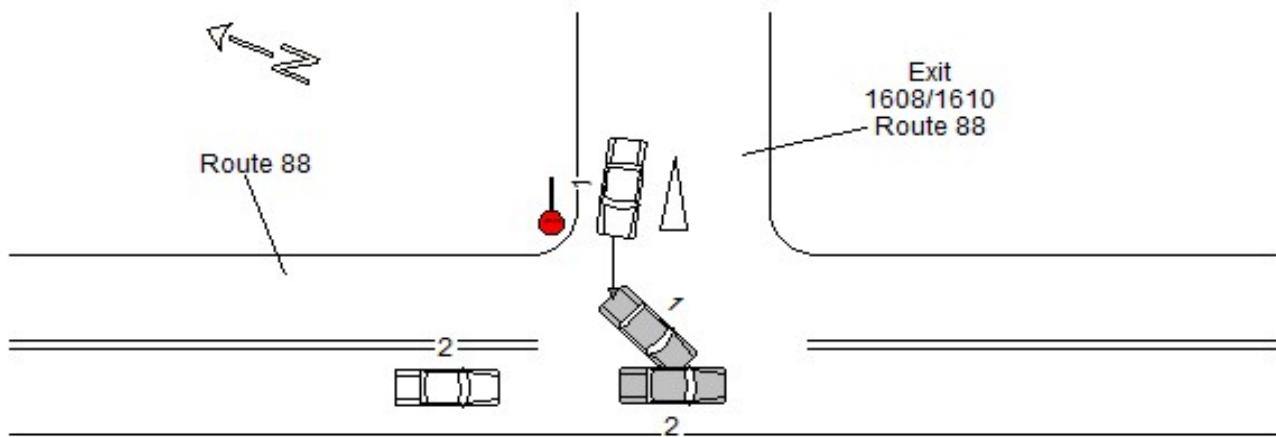
