Vehicle # 2 was legally parked between the white lines of the parking stall located in front of Camp Mall (1905 Rt. 88) and unoccupied. 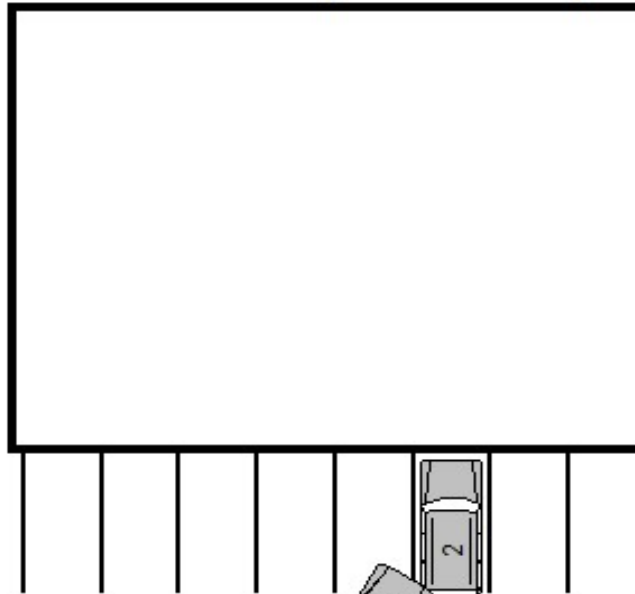
