135 Crash Description

Vehicle #1 was backing east out of a parking space at the Walgreen's store (1890 Route 88). Vehicle #2 had already backed out of a space across from Vehicle #2. Vehicle #1 backed into Vehicle #2 that was in the lane of travel before Vehicle #1.

The driver of Vehicle #1 stated that she did not see Vehicle #2 already in the lane of travel and backed into it. The driver of Vehicle #1 apologized to the driver of Vehicle #2.

The driver of Vehicle #2 stated that as she backed out of her parking space, she saw that Vehicle #1 was backing and tried to avoid the crash by pulling forward. She added that she was not in time and that Vehicle #1 crashed into her.

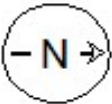
