135 Crash Description

Driver of vehicle 1 stated she backing out of a parking space in the parking lot of 1872 Rt 88. Driver of vehicle 1 stated while backing, she struck the front of vehicle 2. Driver of vehicle 1 reported she was scared because she was unlicensed so she left the scene without contacting police. Driver of vehicle 1 stated after leaving the scene of the crash she decided to return.

Owner of vehicle 2 stated her vehicle was parked in the parking lot of 1872 Rt 88. Owner stated she returned to her vehicle and noticed the damage. Owner stated she spoke with a witness, whom advised her of the crash.

Investigation revealed; Vehicle 1 and 2 both were parked in the parking lot of 1872 Rt 88. Vehicle 1 was backing out of the parking space as vehicle 2 remained parked. Vehicle 1 was improperly backing out of the parking space, struck the front of vehicle 2, causing the crash.

Vehicle 1 left the scene prior to the owner of vehicle 2's arrival.

Vehicle 2 was in the original point of impact at the time of the investigation.

Walmart employees advised the crash was captured on camera, and they would hold a copy of the video for safe keeping.

There were no reported injuries at the time of the investigation.

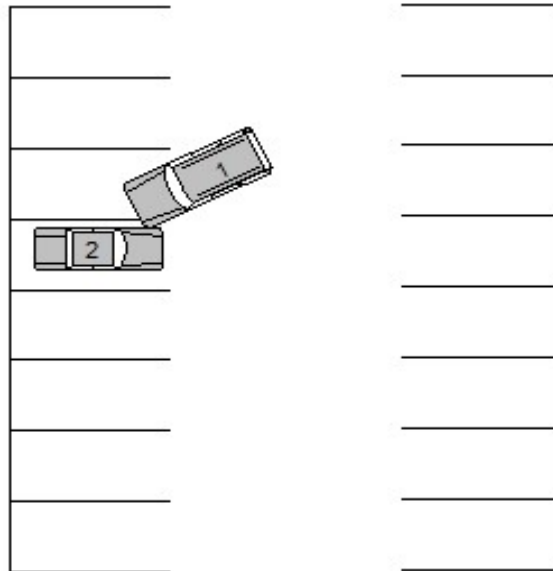
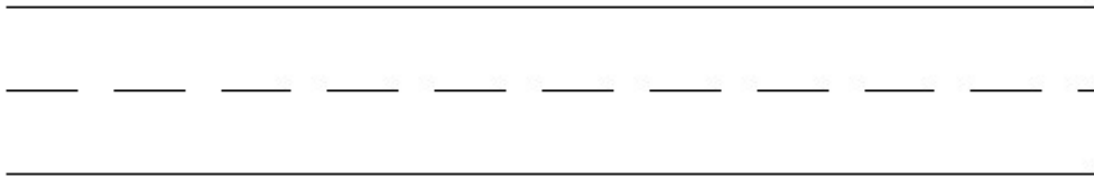
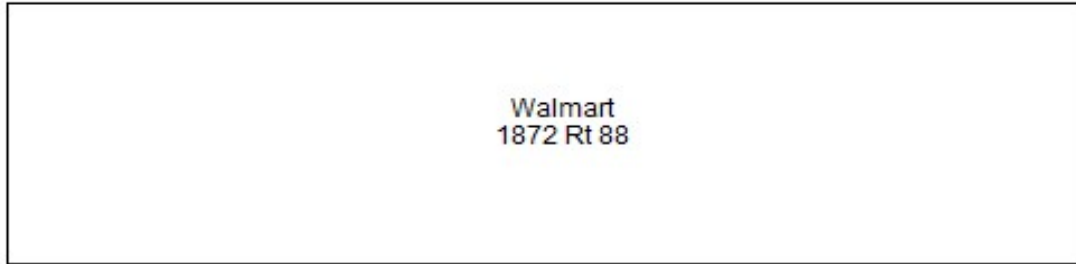
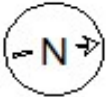
