Vehicles 1 and 2 were parked in the parking lot of the Home Depot located at 1722 RT88, in adjacent parking spots. Both vehicles began to back out, and collided in the travel lane.

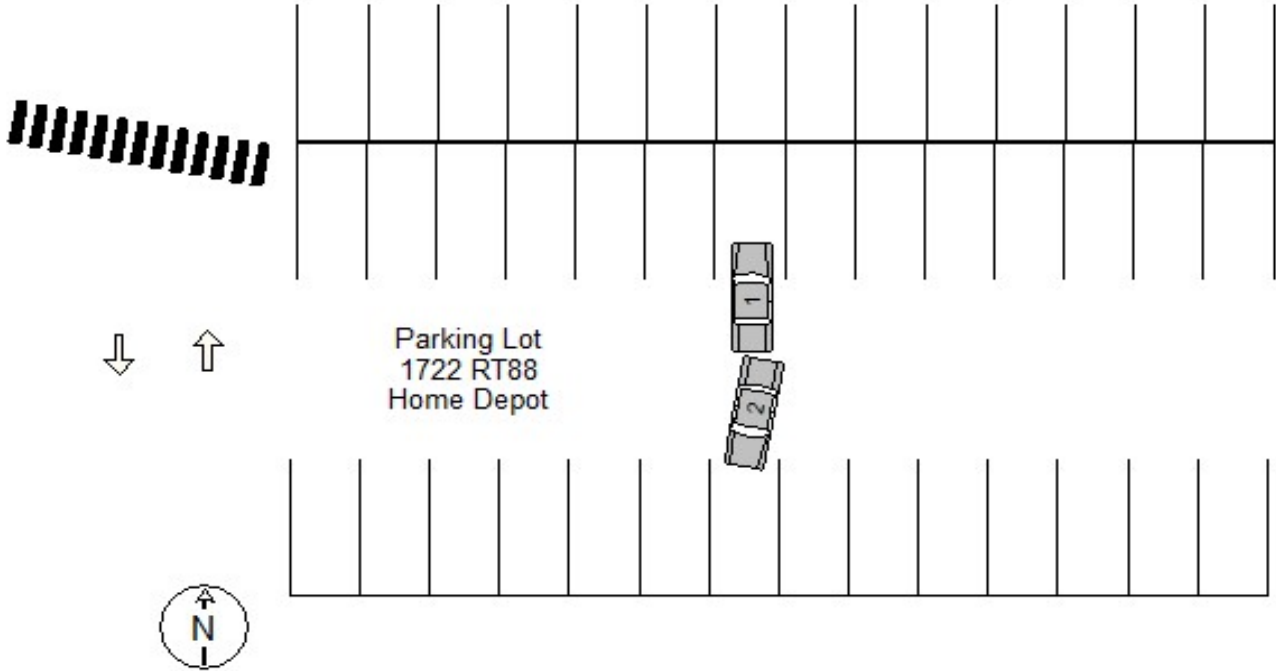
