135 Crash Description

Vehicle 1 was backing from a parking space in the Walmart parking lot. Vehicle 2 was traveling East in the travel lane of the parking lot. Vehicle 1 and vehicle 2 collided in the travel lane.

Driver 1 stated that she looked before backing and that vehicle 2 struck her as she was more then half way backed out of the spot. Driver 2 stated that vehicle 1 backed out of the space into her.

There was damage to vehicle 1 on the rear bumper at the 7 o'clock position, but driver 1 stated that it was existing damage and no new damage occurred due to this crash.

The driver of vehicle 1 was determined to be at fault for the collision due to backing unsafely.

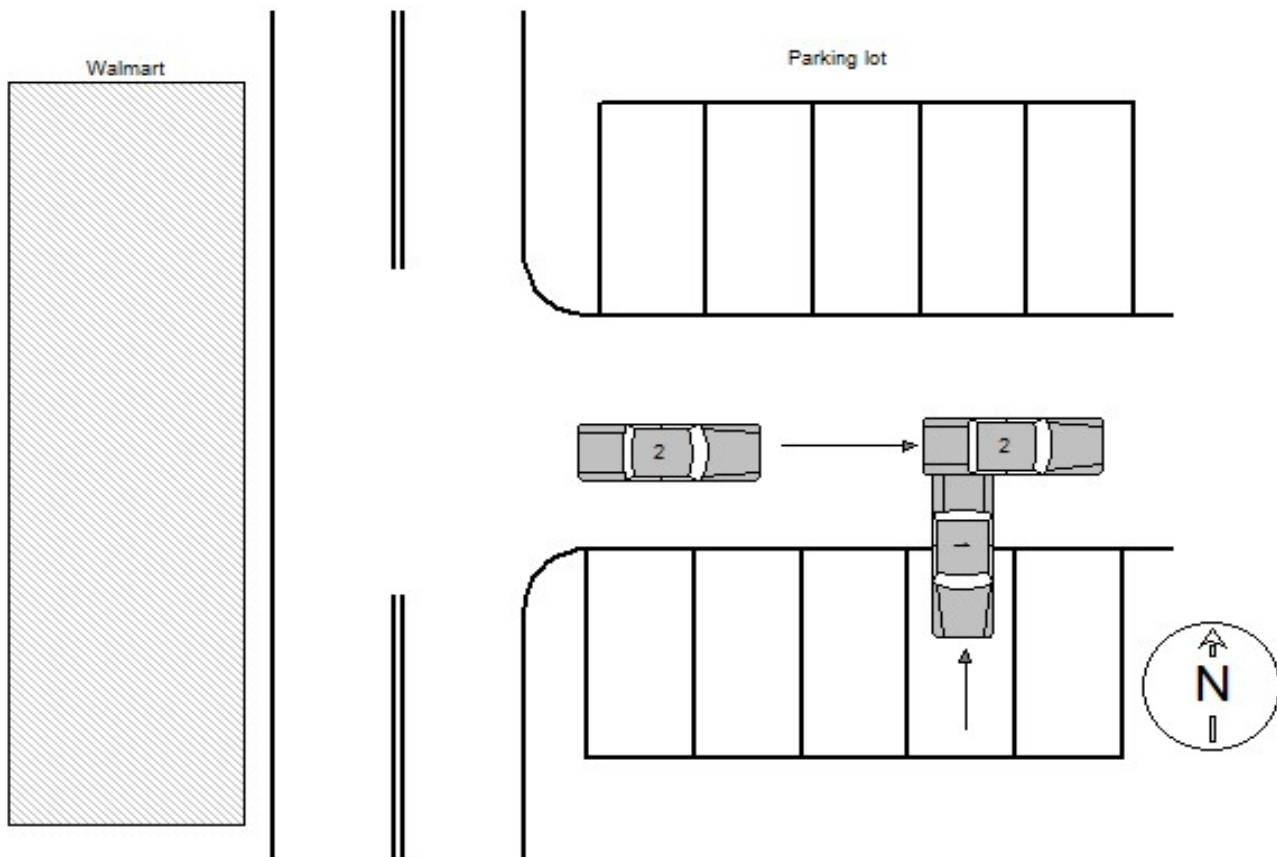
