135 Crash Description

Investigation reveals vehicle 2 was stopped on Rt. 88 with its left blinker on waiting to make a left into the dirt lot where a hotdog truck was parked. Vehicle 1 was traveling east on Rt. 88 approaching vehicle 2.

Driver of vehicle 1 states vehicle 2 did not have her blinker on and she rear ended vehicle 2. Vehicle 2 states she was fully stopped with her left blinker on preparing to make the left when her vehicle was struck from behind.

Vehicle 2 spun and struck vehicle 3 which was traveling west on Rt. 88. Driver of vehicle 3 suffered no injuries. driver of vehicle 1 was transported to the Brick ER with chest pain. Driver of vehicle 2 was brought to the Brick ER with lower leg pain. Juvenile passenger of vehicle 2 was brought to the Brick ER for precautionary reasons, no specific injury was given.

Driver of vehicle 1 was issued a Careless Driving Summons (T#141903).

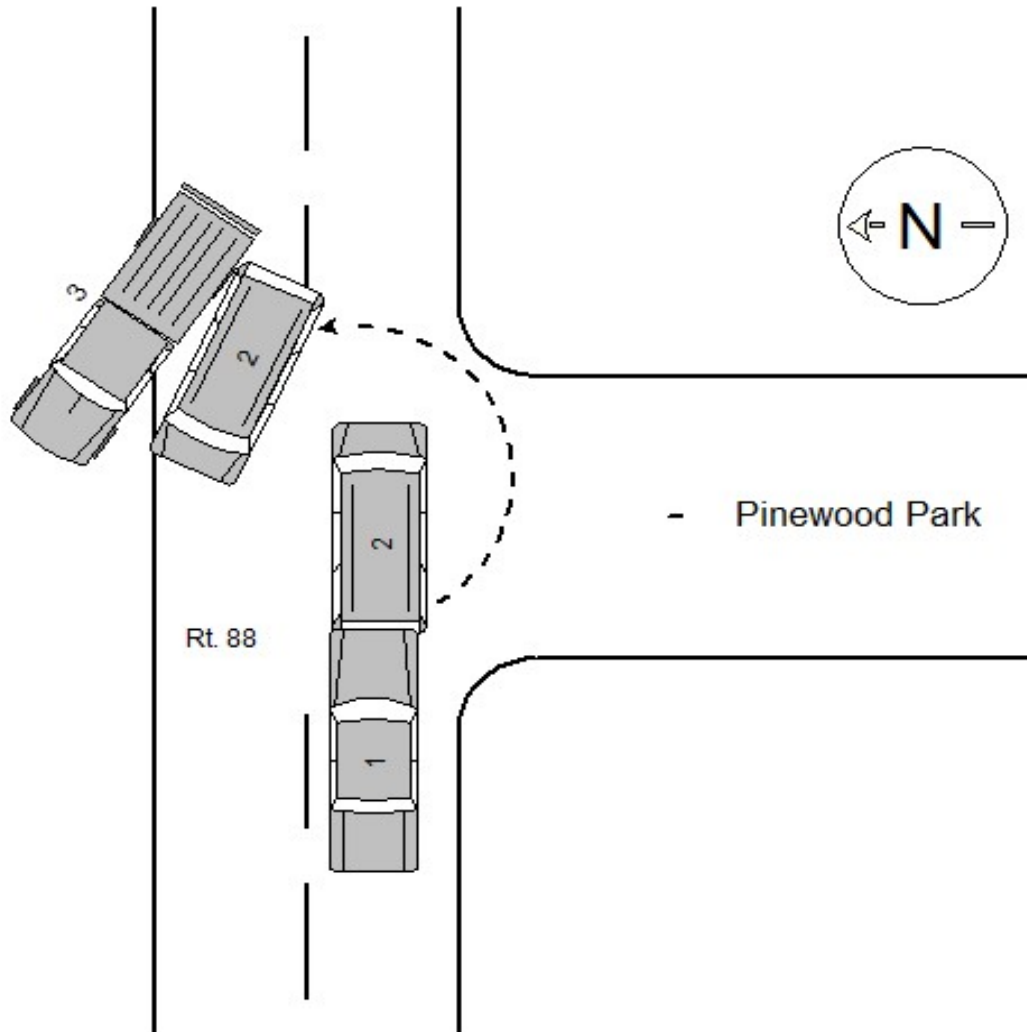
