135 Crash Description

Vehicle 1 stopped at a stop sign at the end of a parking aisle, facing westbound in the parking lot of Walmart, 1872 Route 88. Driver 1 began negotiating a right hand turn onto the main roadway of Walmart. Driver 1 saw a pedestrian caution sign in the middle of the roadway and began making a sharper turn to avoid the sign. As Driver 1 continued his turn, the passenger side rear of his vehicle struck the stop sign bollard. The bollard appeared to have very minor damage and the van had damage to the passenger side rear.

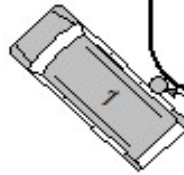
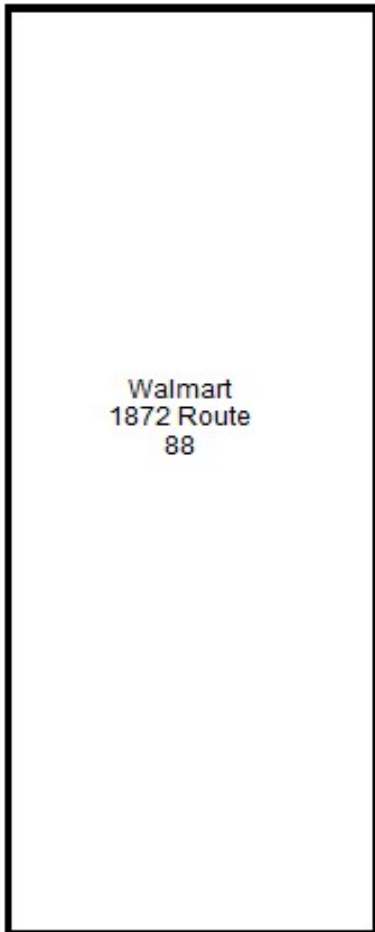
