135 Crash Description

A motor vehicle crash occurred in the parking lot of Welsh Farms/ Domino Pizza. Welsh Farms is 1765 Route 88 and Dominos is 1769 Route 88.

The owner of Vehicle #2 advised she walked out of the Welsh Farms and noticed a note on her windshield. She advised the note stated "7464 New Jersey Transit Bus hit left bumper."

There is damage to the left rear bumper of Vehicle #2. There is no video surveillance in the area of Vehicle #2 nor witnesses.

*Boxes 54 and 55: The owner of Vehicle #2 advised the engine to the vehicle has ceased to operate. She advised the vehicle has been parked for the last few months while she was attempting to fix the vehicle. She stated there has been no insurance on the vehicle for the last few months.

A follow-up was conducted with New Jersey Transit. New Jersey Transit advised bus #7464 is a northern New Jersey bus that does not make any stops in Brick Township. New Jersey Transit advised none of their buses were involved in an crash in Brick Township.

Motor Vehicle Crash Diagram

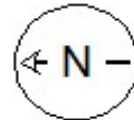
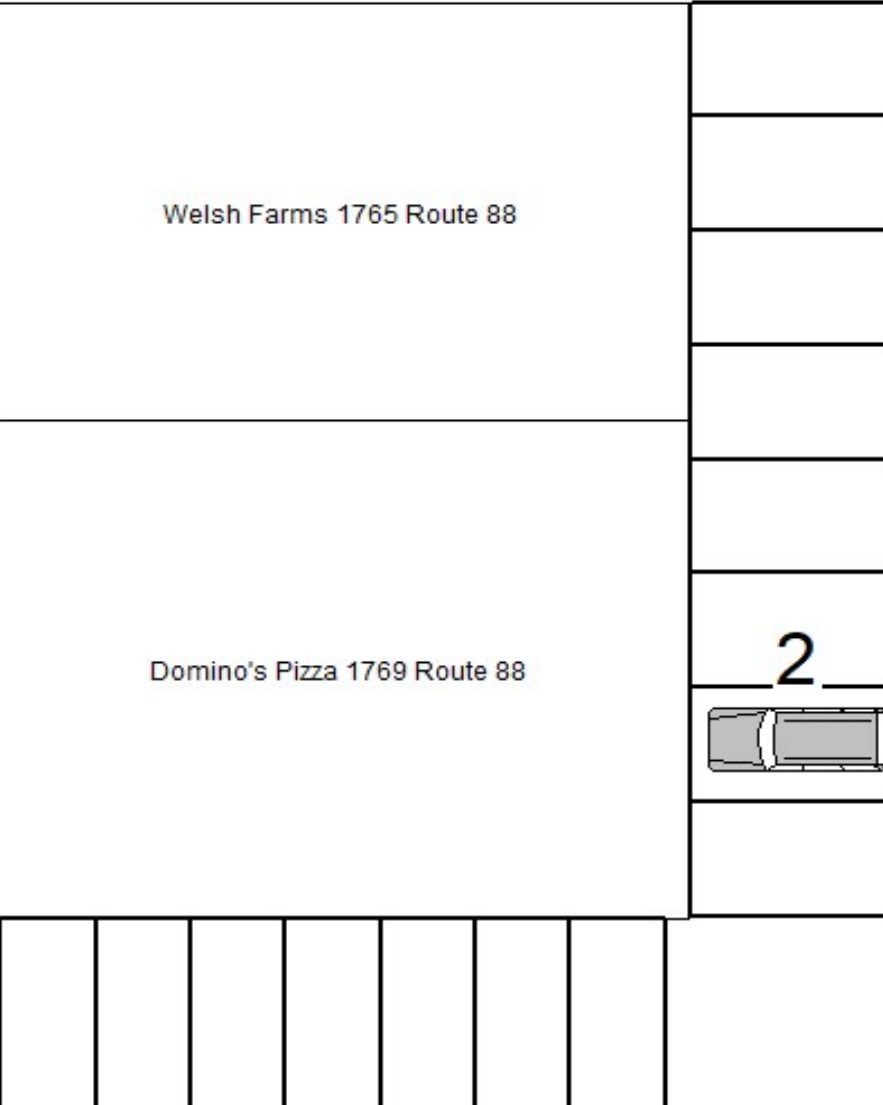
