135 Crash Description

• Vehicle 2 was traveling west on Route 88, area of 1490 (Tuscany Restaurant). Vehicle 1 was traveling east on Route 88, approaching the area of 1490. Driver 1 stated his hands slipped off of the steering wheel, causing Vehicle 1 to travel in a straight line instead of following the curve of the roadway. Vehicle 1 crossed the double yellow line, entered the westbound travel lane, and struck Vehicle 2. Driver 1 complained of pain and bleeding to the right leg. Driver 2 complained of pains in both hands (due to airbag deployment) and pain in his back. Both drivers were treated and released on scene. Driver 1 was issued Summons T-134665 for Careless Driving 39:4-97.

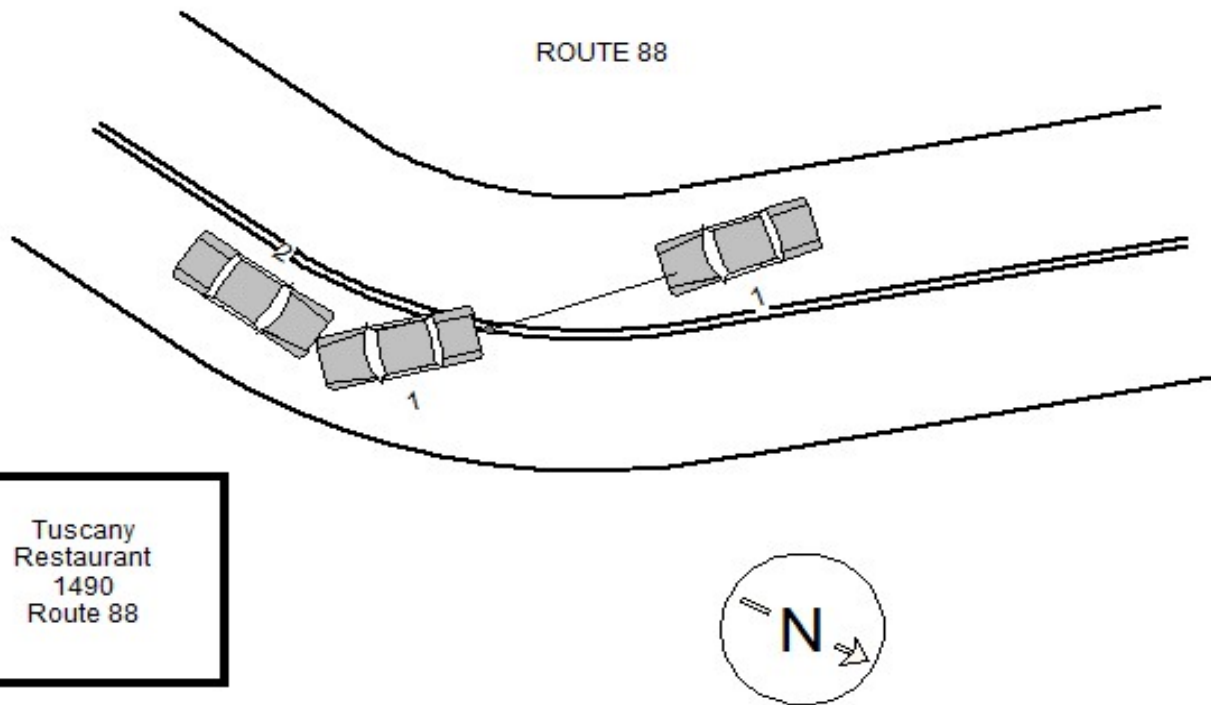
