135 Crash Description

Vehicle #1 was backing out of a marked parking space in the Home Depot parking lot at 1722 Route 88. Vehicle #2 was properly parked next to Vehicle #1 in the Home Depot parking lot and unoccupied.

The driver of Vehicle #1 misjudged the distance between the vehicle he was driving and Vehicle #2 as he backed out of the parking space, striking the passenger side rear-end of Vehicle #2. The collision caused minor damage to both vehicles and no injuries were reported. Both vehicles were driven from the scene.

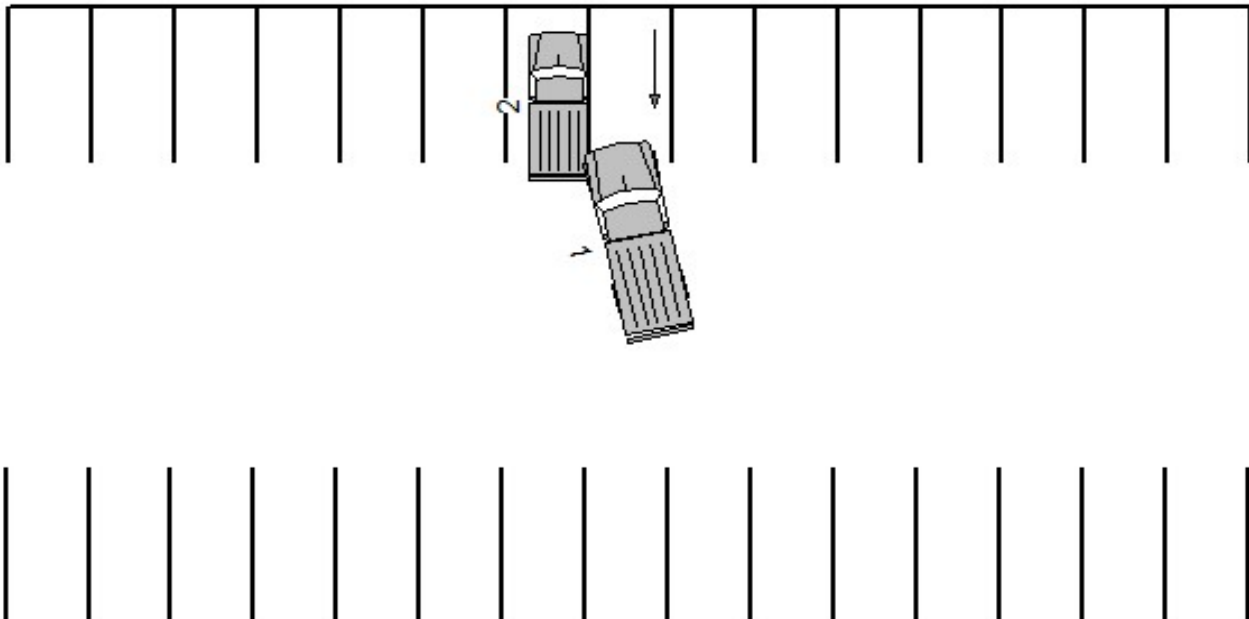
