Vehicle 2 was traveling West on Route 88. Vehicle 1 was stopped on the shoulder of Route 88 West, 100 feet West of the entrance to Home Depot. Driver 1 attempted to make a u-turn on Route 88 to head Eastbound because she missed the turn for United Cash Checking lot (1715 Route 88). Driver 1 did not see vehicle 2 and struck vehicle 2 in the right rear quarter panel. No injuries were reported.

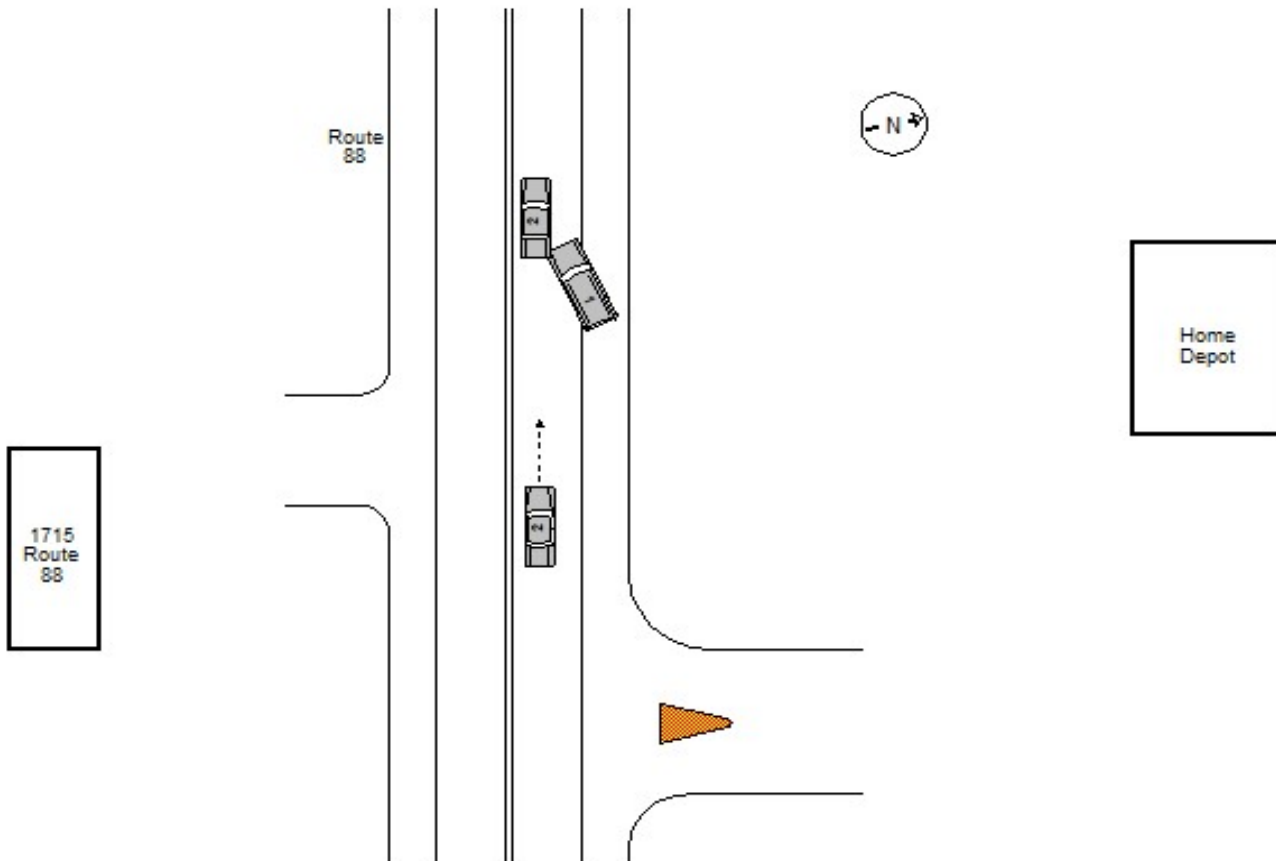
