135 Crash Description

Upon my arrival at the scene I observed Vehicle #2 was facing southbound in the parking lot of Tuscany (1490 Rt.88W) with damage to its rear bumper and trunk. Vehicle #1 left the scene prior to my arrival. Driver #2 stated driver #1 (Kyle A. Matthews) impacted her vehicle in the rear while she was stopped. Driver #1 was upset because driver #2 did not want him to drive due to driver #1 being underage and intoxicated.

Travis Reisig was a passenger in vehicle #2 and he stated Kyle A. Matthews was driving vehicle #1.

Driver #1 was driving his father's vehicle. (Green Dodge Ram)

We were unable to retrieve driver #1's vehicle information or where he resides at this time. I attempted to speak with driver #1 with negative results. I called his cell phone three times and left two messages on his voice mail and he has not responded back.

Toms River Police was dispatched to driver #1's residence and they were advised that driver #1 does not reside at that residence any longer.

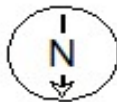

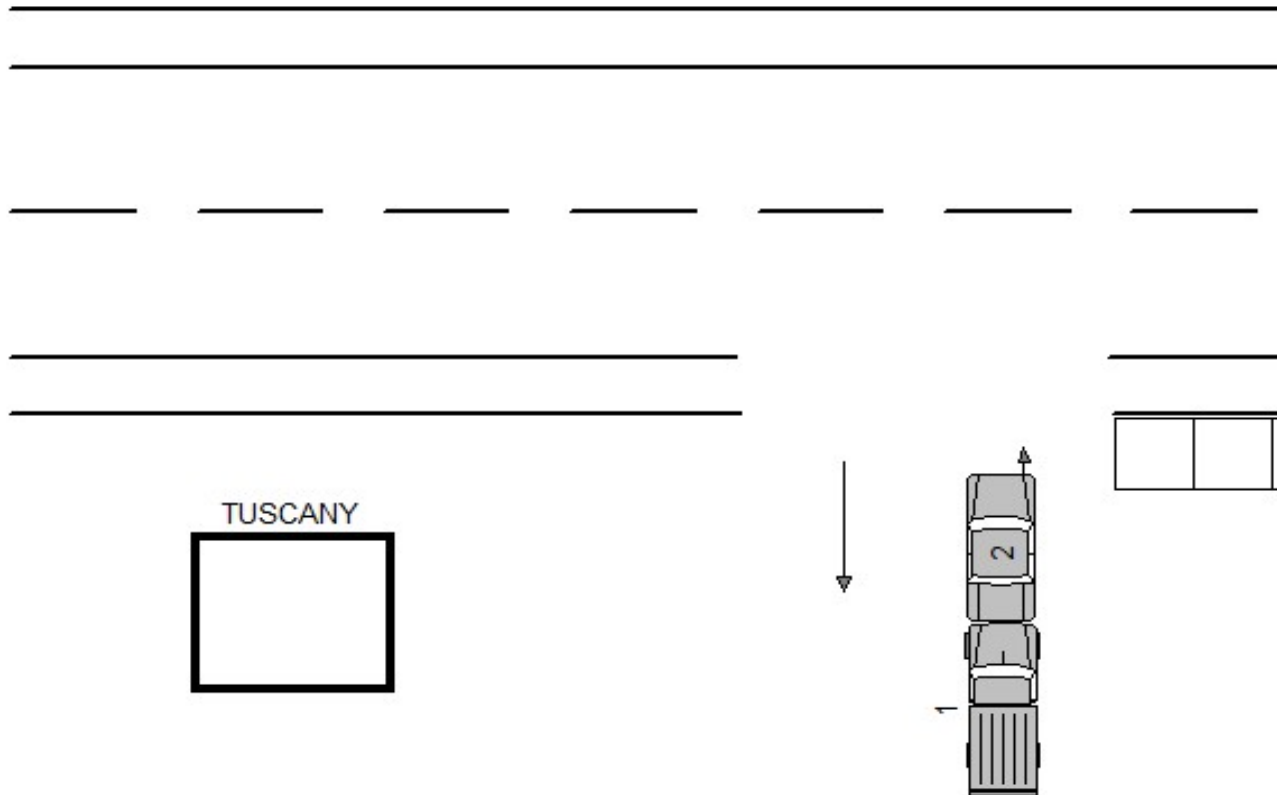
