145. Crash Description/Narrative

V2 was unoccupied and parked facing south in a marked parking space on the property of 1608 Rt. 88. V1 traveled eastbound into the parking lot and attempted a right turn into the marked parking space adjacent to V2.

D1 made a wide turn into the parking space and struck the unoccupied V2.

Video surveillance on the property showed an elderly white male wearing a black shirt and dark jeans exit V1 and assess the damage to both V2 as well as his own. He entered the premises of 1608 Rt. 88 at approximately 1117 hours today, 11/05/2020. An unknown elderly female witness can be seen writing down the information of the suspect vehicle. She proceeds to leave the note on the victim vehicle's windshield. D1 exited the building and returned to his vehicle. Before entering the vehicle, he observes the note on V2, reads it, and removes it before leaving the area.

V1 appears to be a newer model beige Chrysler Town and Country. The registration is illegible in the surveillance.

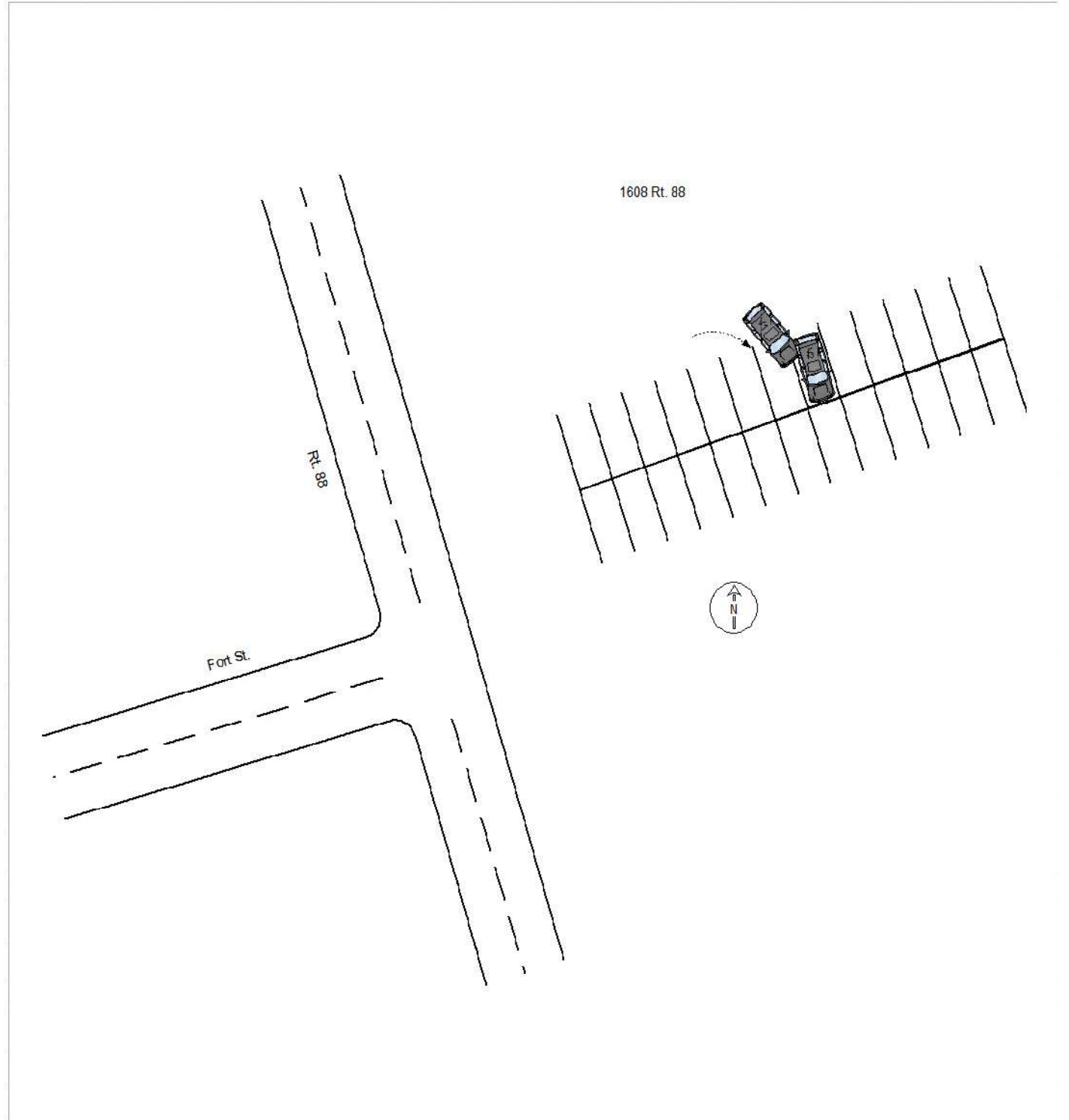
