145. Crash Description/Narrative

Vehicle 2 was legally parked within the lines, backed into a parking space, facing east, in the parking lot of 1608 Route 88. Vehicle 1 was parked next to vehicle 2 on the left of vehicle 2, also backed into the parking space, facing east. Vehicle 1 was pulling out of the parking space, turning right into the parking lot when the right side of vehicle 1 collided with vehicle 2. Vehicle 1 proceeded to pull out of the parking space, the whole time in contact with vehicle 2. As vehicle 1 exited the parking space it pulled the front bumper completely off of vehicle 2. Vehicle 1 left the area without contacting police. I was able to view video surveillance from 1608 Route 88 and observed the above account of events.

The owner of vehicle 2 was located, notified, and responded to her vehicle, confirming there was no damage prior to her parking the vehicle.

I was able to ascertain the driver info for vehicle 1 from the property manager and I responded to his residence. I spoke with driver 1 upon my arrival and he initially denied knowing that he collided with vehicle 2 but did acknowledge he was at the office and parked next to vehicle 2. I observed damage to the passenger side of vehicle 1 consistent with damage that would have been caused by the above account of events. In further speaking

with driver 1 he stated he could not see vehicle 2 because of his tinted windows and that he made a mistake and he should have stayed on scene, indicating he in fact knew that he collided with vehicle 2.

Investigation revealed that the cause of the crash was due to driver 1's inattention to how close he was turning next to a parked vehicle along with his view possibly being obstructed as indicated, because of the window tint.

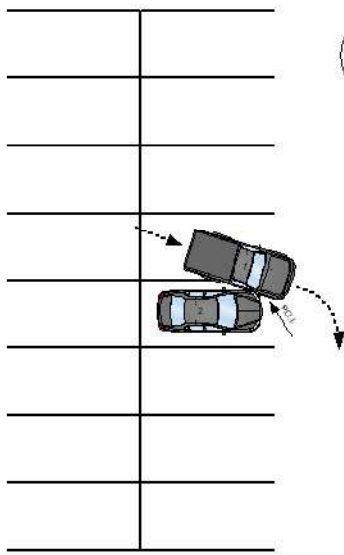

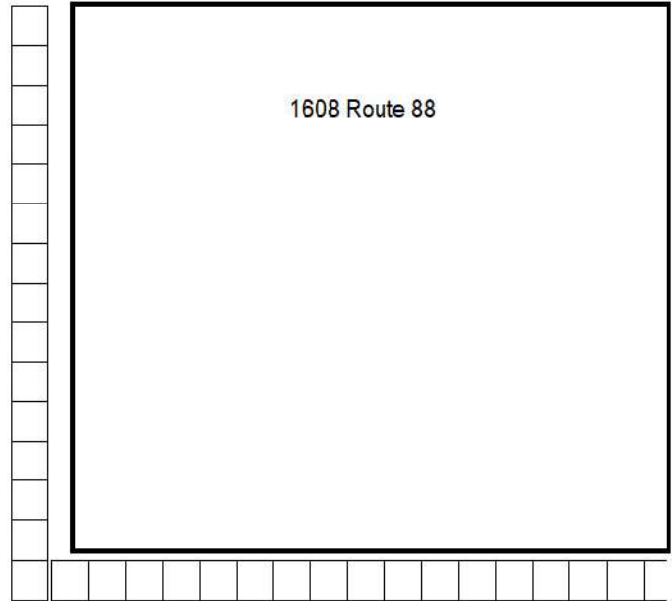
