145. Crash Description/Narrative

Vehicle 1 was traveling west in the parking lot of Walmart and attempted to make a left turn, heading south in front of the building. Vehicle 1 left the roadway, running off the road to the right, and collided with a fixed bollard pole in front of the store, after which he left the scene only to return a couple of hours later at the request of the store manager.

I observed video surveillance of the crash and observed the above account of events. A copy of the surveillance video was provided by Walmart, logged, and placed into property.

I then spoke to driver 1 who advised that he was hurrying out of the parking lot, making the left turn when he struck the pole. Driver 1 stated he did not see the pole due to the top of it being "sheered off" even though he stated he knows there are poles along the length of the front of the store.

Investigation revealed that the cause of the crash was due to driver 1's inattention to the location of a fixed object that he admittedly knew was there to begin with.

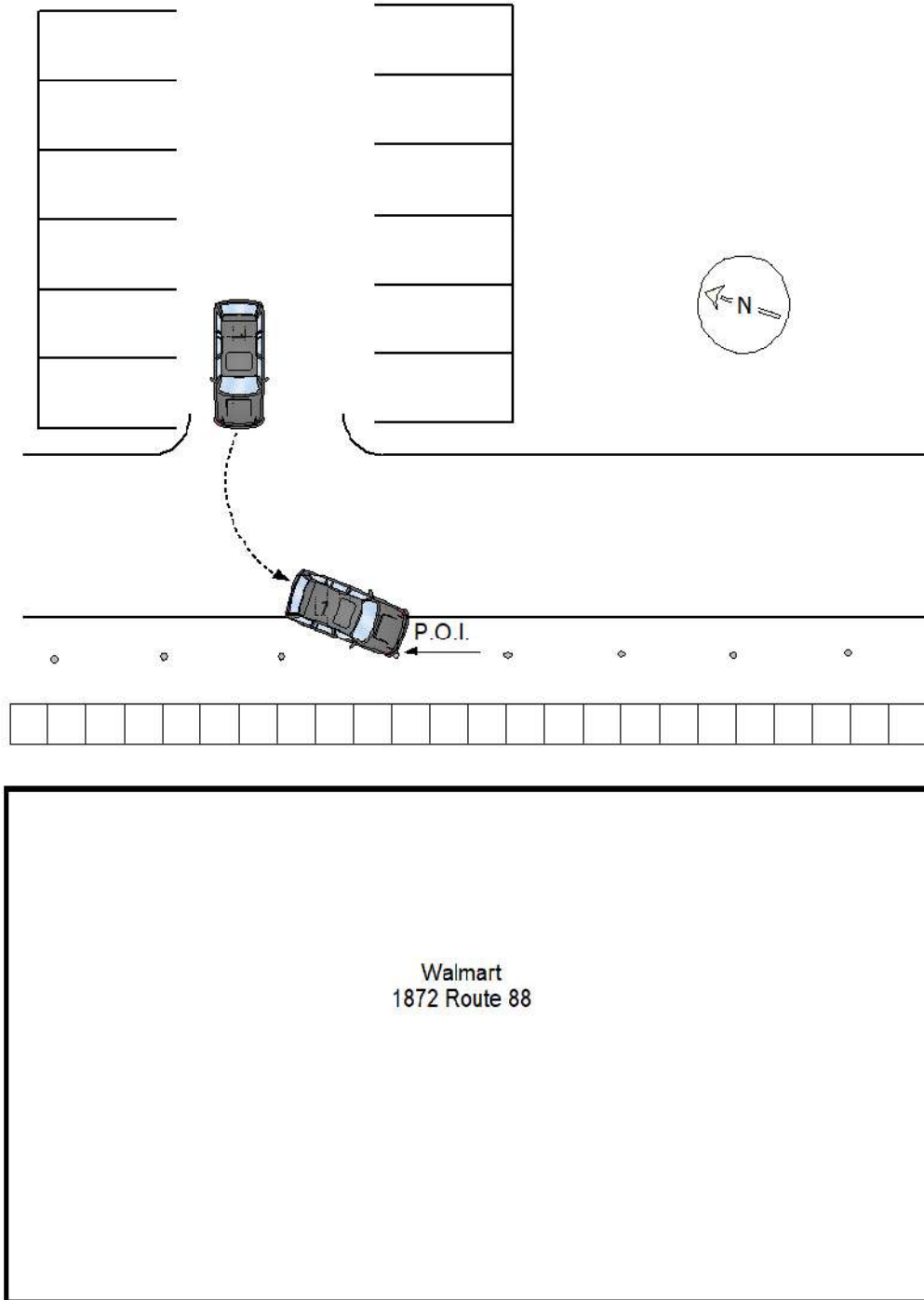
