145. Crash Description/Narrative

On 1/13/21 at 1920 hours I was dispatched to 1722 Rt 88, Home Depot, in reference to a hit and run accident.

Upon arrival I spoke with the owner of vehicle 2. He advised he had just left work and noticed his vehicle had damage on the left side. When he looked further he noticed a note on his windshield from someone who witnessed the accident. He made contact with the witness and she provided him with a picture of the suspect vehicle's (vehicle 1) license plate (NJ/J38-JND).

I contacted Spring Lake Police Department and spoke with Ptl. Algor#127. Ptl. Algor #127 advised he would respond to the registered owners residence and inquire about the accident. While awaiting their response I spoke with the witness and had her fill out a motor vehicle crash witness statement form which is attached to this report. The witness advised she observed vehicle 1 back out of it's parking stall and hit in to vehicle 2. Vehicle 1 then moved forward to correct itself and backed up again. Vehicle 1 cleared the parking stall and slowly began to drive away without ever stopping to check on vehicle 2.

Ptl. Algor #127 advised he spoke with the owner of vehicle 1 and he confirmed he was operating the vehicle at Home Depot today at the time the accident occurred. He advised he did not recall hitting anything. Ptl. Algor#127

observed damage that was consistent with what occurred at the scene of the accident. The driver of vehicle 1 advised he didn't even notice it until the officer pointed it out to him. Ptl. Algor #127 was able to provide me with vehicle 1's insurance policy information.

I was able to speak with the driver of vehicle 1 via telephone. When I asked for his statement he advised he was told by Ptl. Algor #127 that he had hit a vehicle, but he had no recollection of the accident. When I provided him with the account of the witness he advised he did exactly what they said, but he believed he had hit a curb and moved forward to realign himself so he could clear it when he backed out again.

Investigation at the scene revealed vehicle 1 was at fault. While backing out of it's parking stall the lower right front of vehicle 1 crashed in to the left middle of vehicle 2 causing damage to both. Both vehicles were driven away from the scene and no injuries were reported at this time. The driver of vehicle 1 was issued summonses for 39:4-97, 39:4-130, 39:4-129. All summonses were served via certified mail.

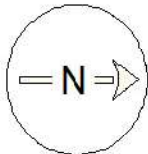

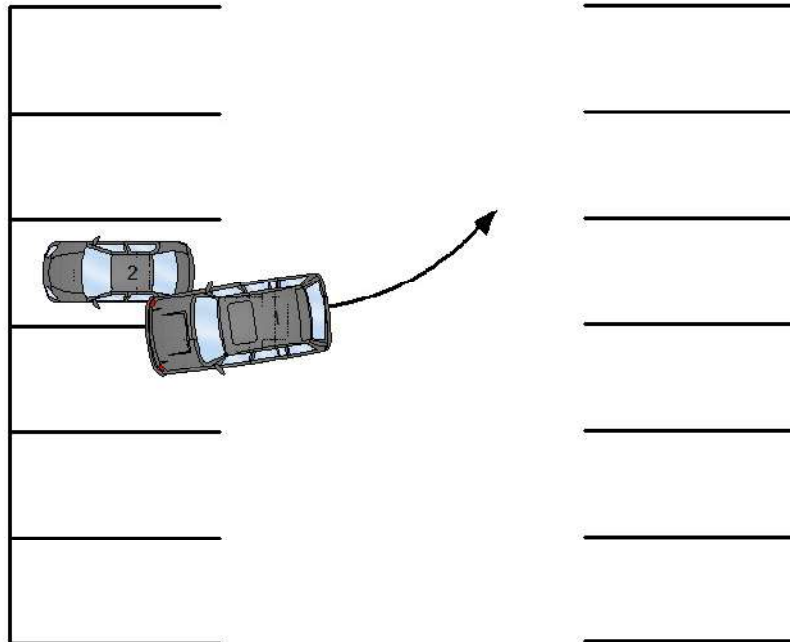
144 Crash Diagram (NOT TO SCALE)
