145. Crash Description/Narrative

Vehicle #1 was parked in a marked paring space in the parking lot of Walmart, located at 1872 Route 88. Vehicle #2 was parked in the spot directly behind Vehicle #1.

Driver #1 stated he backed out of his parking space and into the middle of the aisle. As he was switching his car to drive, he was struck by Vehicle #2. Vehicle #1 suffered damage to the driver's side quarter panel and rear bumper.

Driver #2 stated he was backing out and did not see Vehicle #1 already backing out. His backup camera and backup alerts did not go off and as he was backing up he felt the rear of his vehicle strike Vehicle #1. Vehicle #2 did not suffer any damage.

Based on my observations and both statements made by the drivers on scene, I determined Vehicle #2 to be at fault for the crash.

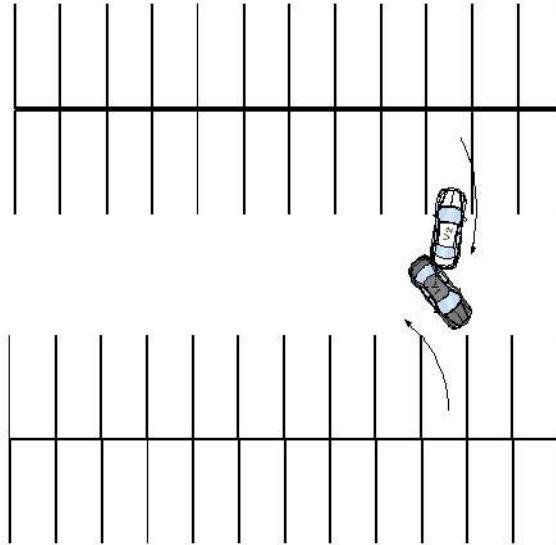
