Vehicle 2, a Brick Township School Bus was stopped on Route 88 west. The bus had it red lights activated. The driver states he was half in the shoulder and half in the lane. 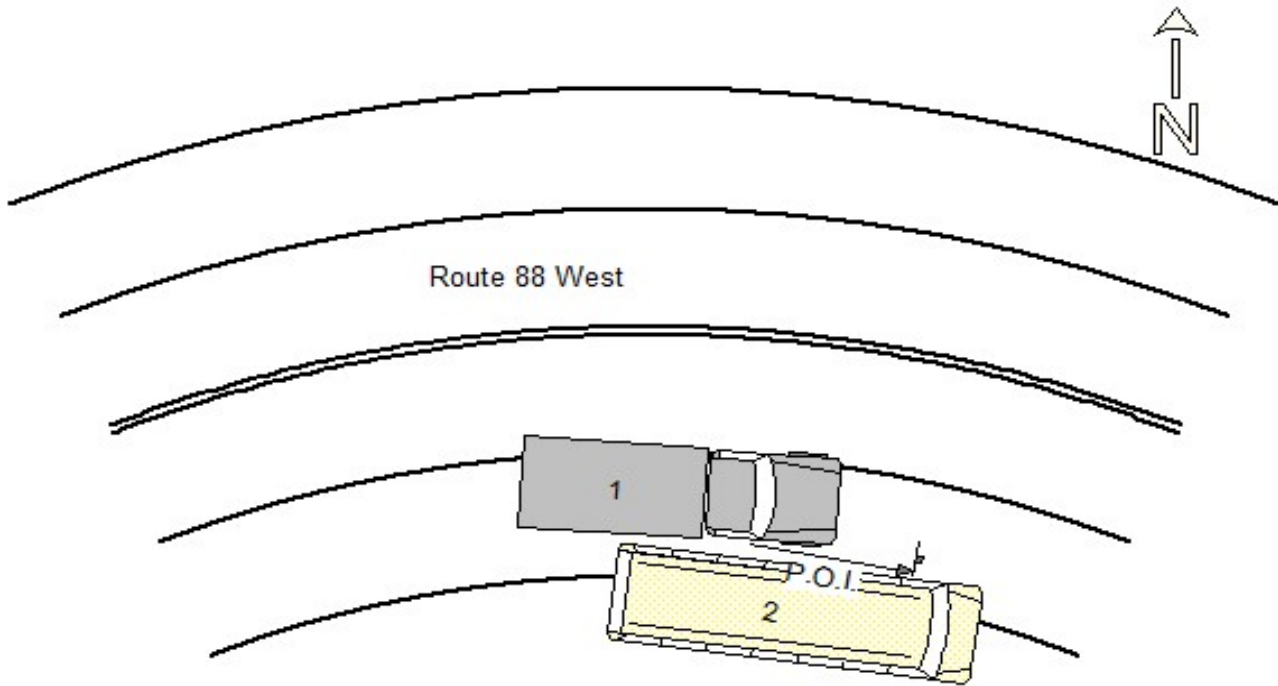
