135 Crash Description

Investigation at the scene indicated the following: Vehicle 1 was attempting to exit the westernmost driveway of 1451 Highway 88 on to Highway 88 westbound. Vehicle 2 was traveling west on Highway 88. Vehicle 2's front contacted Vehicle 1's right side.

The driver of vehicle 1 told me that he did not see vehicle 2. The driver of vehicle 2 told me that he saw vehicle 1 begin to pull out, then hesitate, then continue into the roadway. He stated that he attempted to avoid vehicle 1 but could not.

Vehicles were moved prior to police arrival. Based on the drivers' statements, vehicle damage and debris, I issued the driver of vehicle 1 summons #T124416 for 39:4-66.

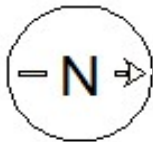

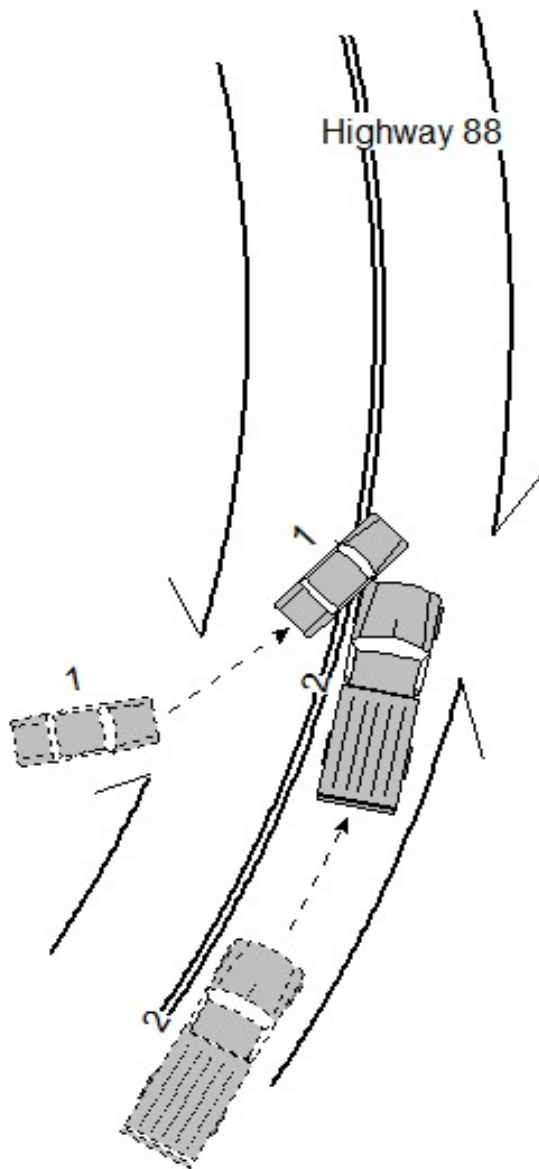
