Vehicle #1 was traveling north on Post Rd. in the left lane going straight ahead. Vehicle #2 was stopped at a traffic light in the left lane on Post Rd. directly in front of Vehicle # 1 waiting to make a left turn. Driver of Vehicle #1 was not paying attention and impacted the rear of Vehicle # 2 causing small scratches on the left side of the rear bumper. Vehicle #1 sustained a small scuff mark on the right side of the front bumper. Driver of Vehicle #1 was issued a summons for Failure to Exhibit Documents (Insurance Card; T-124625) and Uninsured Vehicle (T-124626). Driver of vehicle #1 was given 48 hours to provide proof of insurance, but has failed to do so. No injuries were reported at the scene.

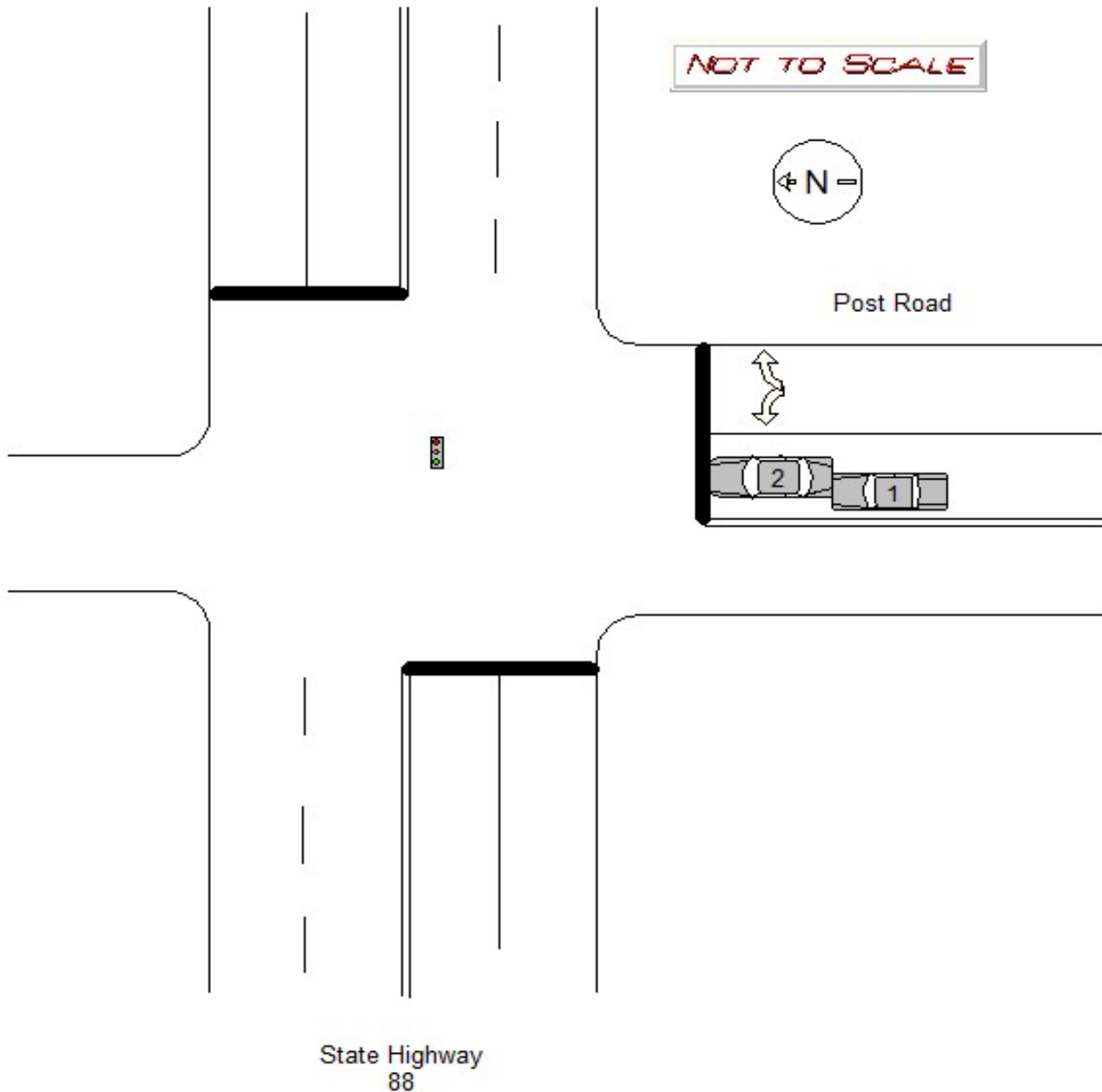
