145. Crash Description/Narrative

Vehicle #1 was attempting to pull into a marked parking space in the parking lot of 1640 Route 88. Vehicle #2 was parked in a marked parking space, unoccupied, directly to the right of the space Vehicle #1 was trying to park in.

A witness stated she was standing approximately five spots away waiting for an Uber when she heard the collision. She observed Vehicle #1 stop for a moment and then reverse out of the parking space and park approximately 10 spaces away in the back of the lot. The witness was able to provide license plates and vehicle descriptions to both vehicles.

Upon my arrival, Vehicle #1 was no longer on scene but Vehicle #2 was still parked, with damage to the driver's side quarter panel and rear door. There was a slight amount of tan paint transfer but mainly small pieces of rubber were observed hanging from the vehicle. The vehicle owner was located inside the medical building, 1640 Route 88, and confirmed there was no damage to his vehicle when he parked it.

I responded to the registered owner's house and spoke with Driver#1's wife, Samantha Maione, who confirmed her

husband drives a tan Chevrolet Silverado and had a doctor's appointment in that building this morning. She was able to provide the insurance information for the vehicle and attempted to call Driver #1 but he did not answer. Later in the day, Driver #1 called Headquarters and I was able to speak with him via telephone. He stated he did not know he struck the vehicle. He explained he was going to pull into the spot and realized it was too tight so he backed out and found another spot. He claimed he had no damage to his vehicle.

Based on the witness' statement, my observations on scene, and Driver #1's statement on the phone, I determined he would have known he struck Vehicle #2 based on the damage Vehicle #2 received and the sound it caused which was heard by the witness, approximately 20 feet away.

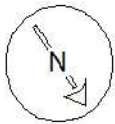

Motor Vehicle Crash Diagram

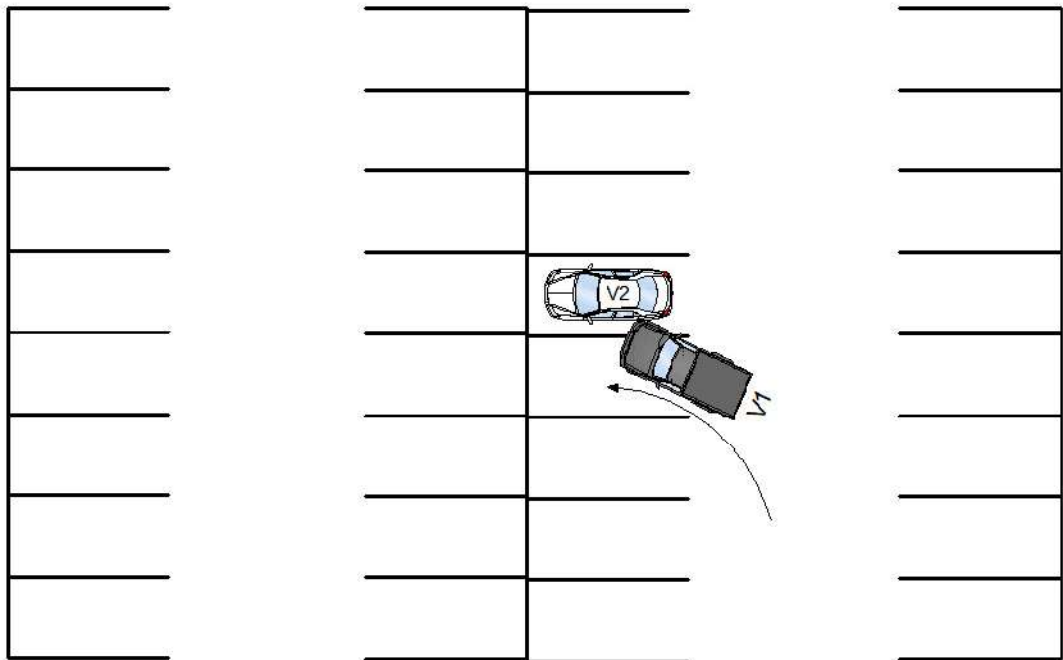
