145. Crash Description/Narrative

Vehicle 1 was initially traveling north through the parking lot of Home Depot, 1722 Route 88, closest to Route 70. Vehicle 2 was traveling directly behind vehicle 1. Vehicle 2 turned his vehicle to the left in order to back into a parking space, vehicle 1 was continuing north through the parking lot and ultimately behind vehicle 1. When vehicle 1 began to back up into the parking space vehicle 2 was stopped behind him and unable to move in time. Vehicle 1 backed up into vehicle 2.

Driver 1 stated he was traveling north through the parking lot of Home Depot and he turned his vehicle to the left in order to back into a parking space. Driver 1 stated when he began to back up vehicle 2 was behind his and he did not realize, subsequently backing up into vehicle 2. When I asked him, Driver 1 stated he did not believe he had his turn signal on indicating that he was parking and not turning down the lane of travel to his left.

Driver 2 stated she was traveling north through the parking lot of Home Depot behind vehicle 1 and vehicle 1 began to make a left turn down a lane of the parking lot. Driver 2 stated she was behind vehicle 1 as it began to back up. Driver 2 stated she beeped her horn and tried to back up out of vehicle 1's way but was unable to in time and that vehicle 1 backed up into her. Driver 2 stated she did not see a turn signal indicating vehicle 1

was parking to the right and believed vehicle 1 was making a left turn to proceed down that travel lane through the parking lot.

Investigation revealed that there were multiple factors that contributed to the cause of the crash. First Driver 1 was turning left into a travel lane in the parking lot, giving the impression that it was safe to pass behind. Second Driver 1 did not signal whether he was turning left or he was going to be parking in a parking space on the right.

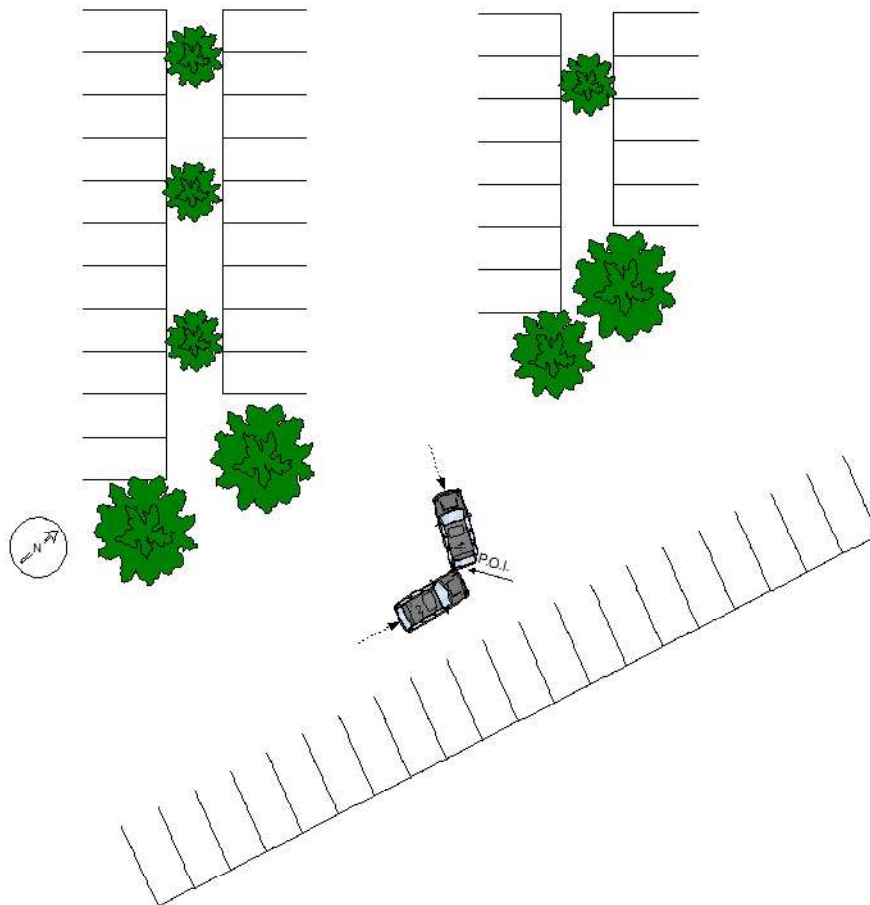
