145. Crash Description/Narrative

The driver of vehicle #1 stated she was exiting the parking lot of 1872 Rt. 88, cutting across a parking space, making a right turn to avoid other traffic. She stated that when she turned she did not realize that she hit a vehicle and thought she hit a snow bank. She stated she kept going and left the area.

The owner of vehicle #2 stated he exited the store and came out to his vehicle. He immediately noticed the rear bumper hanging off of the vehicle and on the ground. He spoke with a subject in the parking lot who provided him with the license plate and description of vehicle #1.

No injuries reported. Moderate damage to vehicle #2. Minor damage to vehicle #1.

Based on both parties statements, it is my determination that vehicle #1 caused the crash by carelessly driving.

Failure to report MVA T 164809 39:4-130

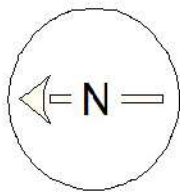

Motor Vehicle Crash Diagram

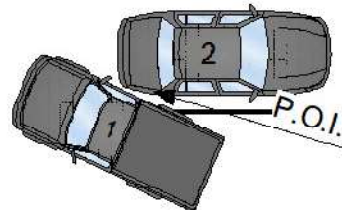
