135 Crash Description

The owner of vehicle #2 advised that her parked vehicle was struck by a large moving truck(vehicle #1) that left the property after the collision. She also advised that there is video surveillance on the property that shows the collision. I went into the office of 1481 Rt. 88 west and viewed the video which showed the following.

Driver #1 was attempting to back a large moving truck off the property. As the driver was backing up, vehicle #1 struck vehicle # 2 multiple times as he moved backward and forward, trying to navigate the parking lot. Each time vehicle #1 struck vehicle #2, vehicle #2 violently moved. The driver of vehicle #1 then exited the vehicle and walked around the front of the truck and down the passenger side. He stopped halfway down the side of the truck and looked at the rear where the two vehicles were still touching each other. His body language showed signs of frustration as he looked toward the rear of the truck and saw that he had struck the vehicle on its rear bumper. Driver #1 eventually got back into the truck and left the scene without reporting the collision.

The owner of vehicle #2 was able to obtain a contact number for driver #1. When she contacted him he advised that he did not strike anything and refused to respond back to the property. I then contacted him and he initially stated that he did not hit anything on the property. I explained exactly what the video showed and he agreed to respond to police head quarters within the hour. Upon his arrival I met with Driver #1 and obtained some of the vehicle information. I also contacted Penske Truck Leasing and obtained any other needed vehicle information. Penske's reference number is 3387896.

Vehicle #1 is self insured by the Company(owner), Penske Truck Leasing. The truck is an International, 4300 Series. It was rented from L Rentals(0163-48) 1481 Rt.88 Brick,NJ 08723, 732-458-2202.

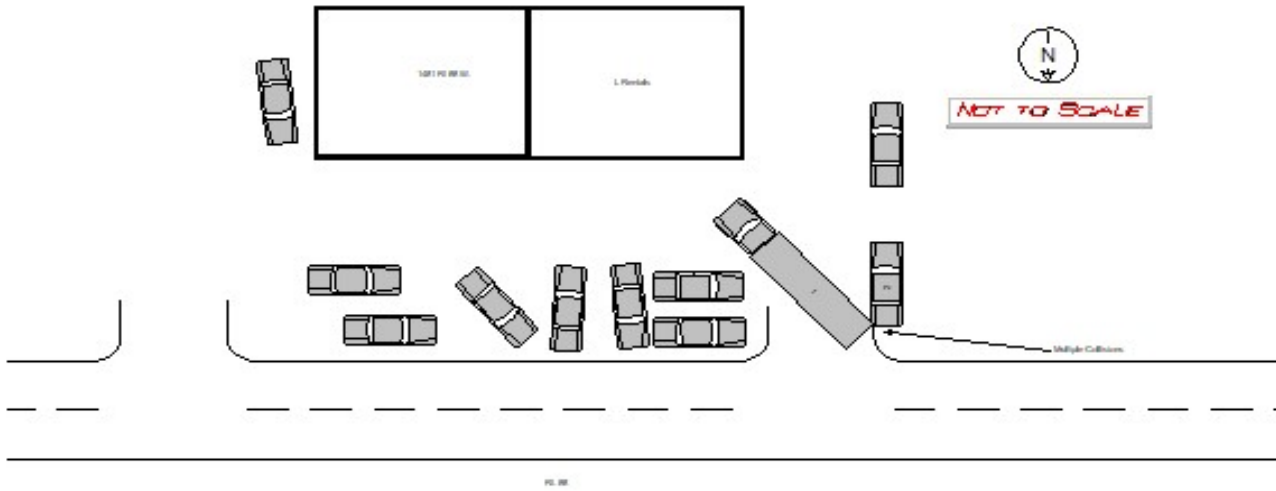
