135 Crash Description

Vehicle 1 traveling Route 88 W/B going straight ahead. Investigation on scene shows that as vehicle 1 was driving, it veered left and crossed over the double yellow lines. After crossing the double lines, vehicle 1 then completely crossed over the E/B lane of traffic, through the median and ran off the side of the road and onto a grassy area. Vehicle 1 then continued moving straight ahead and ultimately collided into a utility pole (pole# JC128BK) before coming to rest against the side of the pole. The force of the impact caused minor damage to the utility pole but caused the primary electrical line on top of the pole to be dislodged.

Driver 1 was able to exit the vehicle on his own and advised he had a complaint of pain in his chest area. He stated he had no recollection of the collision and last remembers driving straight ahead on Route 88 W/B.

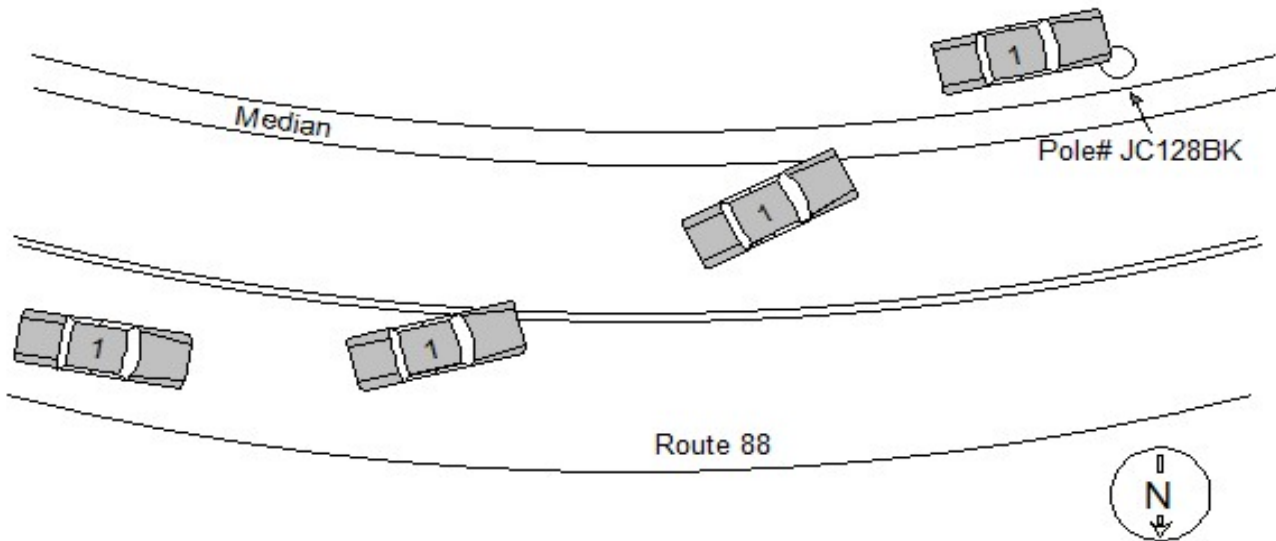
