135 Crash Description

Driver Vehicle 1 reported while attempting to back out of a parking space in the Home Depot parking (1722 RT 88) Vehicle 2 backed into her. Driver Vehicle 1 reported a large van parked to her left obstructed her view while backing. Driver vehicle 1 stated she backed slowly and checked her mirrors repeatedly while backing but did not see vehicle 2 until they made contact. Driver Vehicle 2 reported while attempting to back out of a parking space he observed vehicle 1 backing behind him. Driver Vehicle 2 reported he did not realize their vehicles made contact until he was signaled by vehicle 1. At the time of the report, the vehicles were moved from the original point of impact and I was unable to determine fault. Home Depo video surveillance was unavailable at the time of the investigation. No injuries were reported on scene.

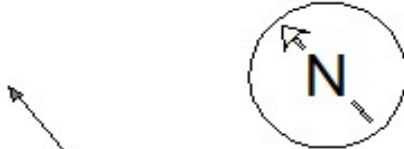

134 Crash Diagram (NOT TO SCALE)

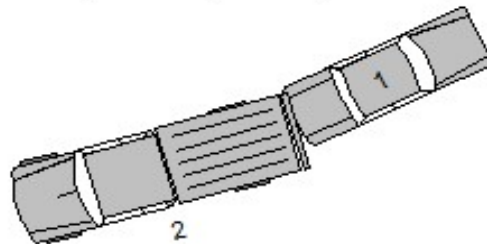
