135 Crash Description

Vehicle one was parked in a designated parking space on the West side of the Tuscany restaurant facing West. Vehicle two was parked in a designated parking space on the West side of Tuscany facing South, approximately 15 feet behind vehicle one. Vehicle one backed into vehicle two while traveling East in the parking lot. Vehicle one departed the area prior to my arrival. A customer advised the owner of Tuscany that he is familiar with driver one, identified her as Anna, provided Anna's phone number (908)907-4178, and license plate (NJ-RKL18M). The customer also witnesses the crash. The witness did not remain at Tuscany until I arrived and could not be identified. I observed a six inch dent, a half inch deep on the passenger side quarter panel and silver paint transfer on the passenger side quarter panel and passenger side door of vehicle two. When I checked vehicle one's plate in DMV it comes back to a silver Ford Explorer. The dent and paint transfer on vehicle two is consistent with the height of the rear bumper of vehicle one. Vehicle two was driven from the scene. Driver one was issued summons T-120247 for careless driving, T-120248 for leaving the scene of an accident and T-120249 for failure to report an accident. I attempted to contact driver one and left several messages. I responded to driver one's residence and observed vehicle one in a parking space. Vehicle one sustained a crack to the driver side rear bumper and also displayed red paint transfer. Driver one did not open the door. A message was left for driver one instructing her to respond to Brick Police Headquarters with valid insurance paperwork. On 12/05/2011 driver one responded to Headquarters and provided insurance documents.
