135 Crash Description

Vehicle 1 was traveling west on Olden Ave, in the left lane of travel. Vehicle 2, who was stopped for the stop sign, was attempting to make a left turn from 1722 Rt 88 (Home Depot) onto Olden Ave (eastbound). The driver of Vehicle 2 stated westbound vehicles in the right lane of travel came to a stop to let him turn, and that he could not see Vehicle 1 approaching in the left lane. Vehicle 2 made the left turn without yielding the right of way to Vehicle 1, and the front left side of Vehicle 2 crashed into the front right side of Vehicle 1, causing damage to both vehicles.

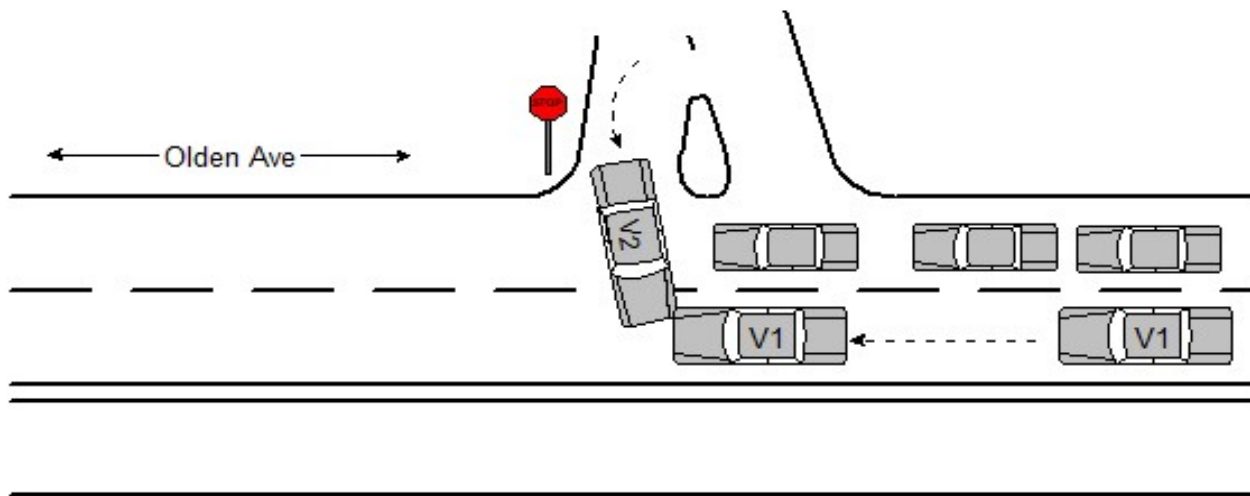
