135 Crash Description

Vehicle 2 was traveling west on Route 88, attempting to make a left turn into the parking area of 1715 Route 88. Vehicle 1 was traveling behind vehicle 2. The crash occurred when vehicle 1 failed to brake, impacting vehicle 2 in the rear. Vehicle 2 was pushed into the eastbound lane of Route 88, impacting vehicle 3 in the lower left rear. All vehicles involved were towed because they were disabled.

The driver of vehicle 1 was issued a summons for careless driving.

The driver of vehicle 1 was transported to Brick Hospital for complaint of leg pain. The passenger of vehicle 2 was transported to Brick Hospital for an abrasion to the face.

A witness, Henry Straub, provided a Witness Statement which has been submitted referencing this case number.

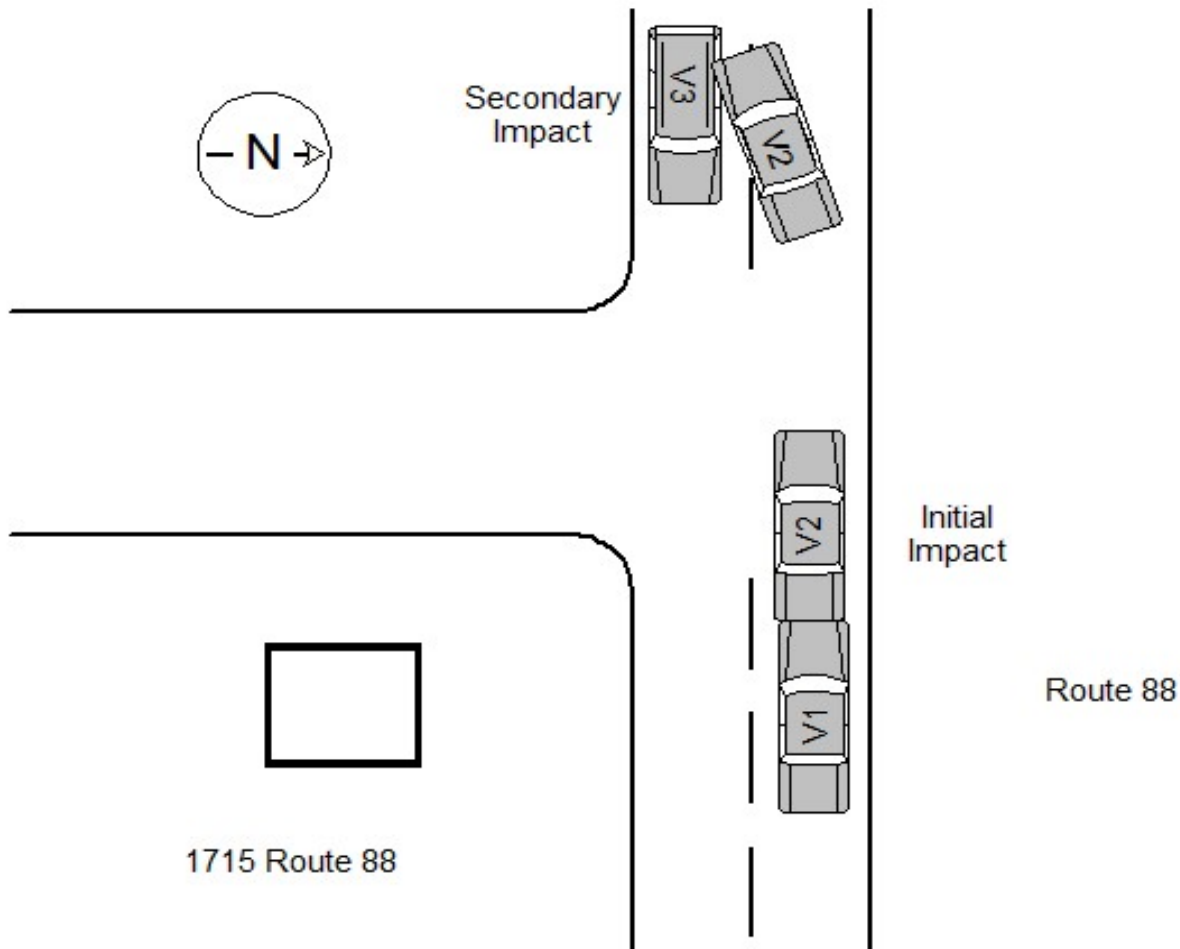
