135 Crash Description

Vehicle 2 was parked, occupied, in the parking lot of 1905 Route 8 (Camp Mall). Vehicle 1 was stopped at the exit, from the parking lot of 1905 Route 88 (Camp Mall). Driver 1 stated she decided to enter a store in the strip mall. She placed Vehicle 1 in reverse, and began to back up in the parking lot, in an eastward direction. Driver 1 stated as she was backing, she placed her foot on the brake, but it slipped off the pedal. Vehicle 1 struck Vehicle 2, causing damage.

No injuries were reported on scene. Driver 1 was issued Summons T-117512 for 39:3-10. In reference to Boxes 54-55, Vehicle 2 is self - insured via the New Jersey Department of the Treasury, Division of Risk Management, P.O. Box 620, Trenton, N.J. 08625.

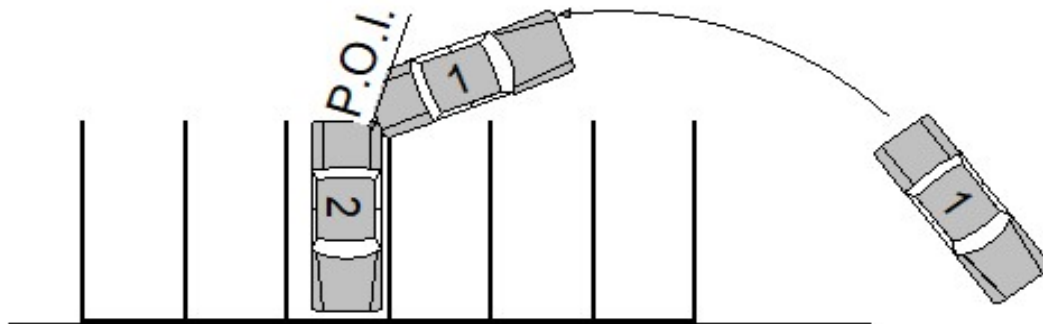
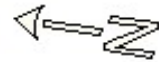
