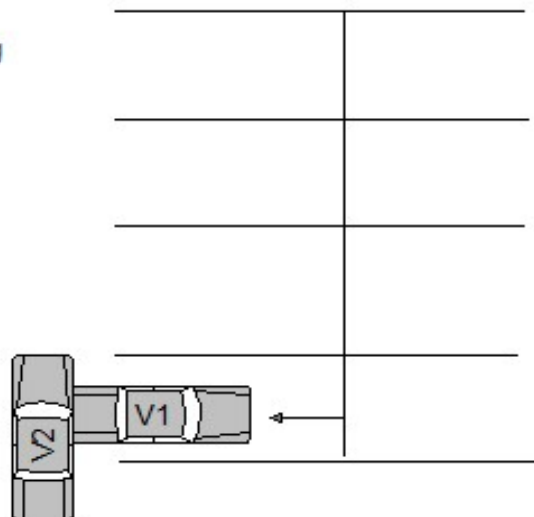
134 Crash Diagram (NOT TO SCALE)
