135 Crash Description

Vehicle 2 was parked and unoccupied in a parking spot in the Walgreens parking lot, 1890 Rt. 88. Vehicle 1 backed out of a parking spot in the same parking lot and struck the rear of vehicle 2. Vehicle 1 then fled the scene. Vehicle 2 driver stated an unknown witness advised her of the crash and of the suspect license plate, NJ registration ZFS96Z. The only information able to be provided was a white female with blonde hair was driving vehicle 1. Vehicle 1 fled the scene in an unknown direction. I attempted contact with the registered owner, via phone with negative results.

On 08/09/10 at 1645 hrs. I was able to speak with the registered owner, via phone, and I was advised the vehicle was not in Brick Twp. at the time of the crash. It is believed the witness copied down a wrong character while attempting to gather the suspect vehicle license plate.

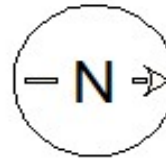

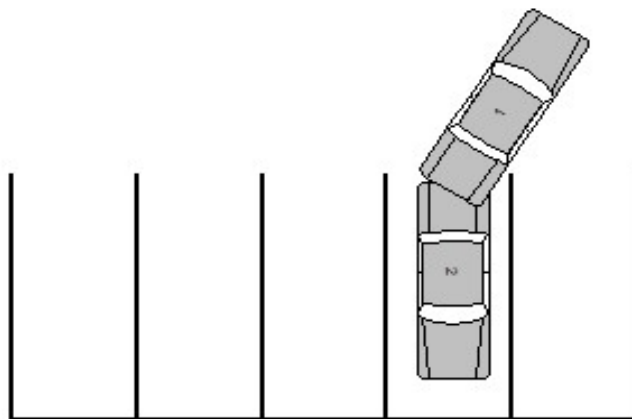
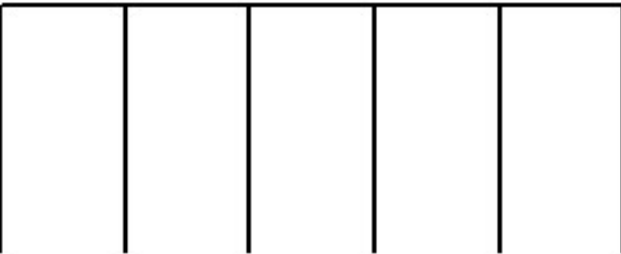
134 Crash Diagram (NOT TO SCALE)
