135 Crash Description

Vehicle #1 was exiting the parking lot of 1457 Rt. 88 (Olympic Gardens), when Vehicle #2 traveling eastbound on Rt. 88W attempted to make a right turn into the same parking lot. Vehicle #2 impacted the front bumper of vehicle #1 causing damage to vehicle #1's bumper and radiator. I did not observe any damage on Vehicle #2. Driver #2 stated he attempted to make a wide right turn into the parking lot so his stereo equipment would not slide onto the floor and did not see vehicle #1. Driver #2 stated that vehicle #1 did not have its headlights on at the time of the impact. I observed Driver #1 turn off and then start his vehicle, the headlights automatically turned on.

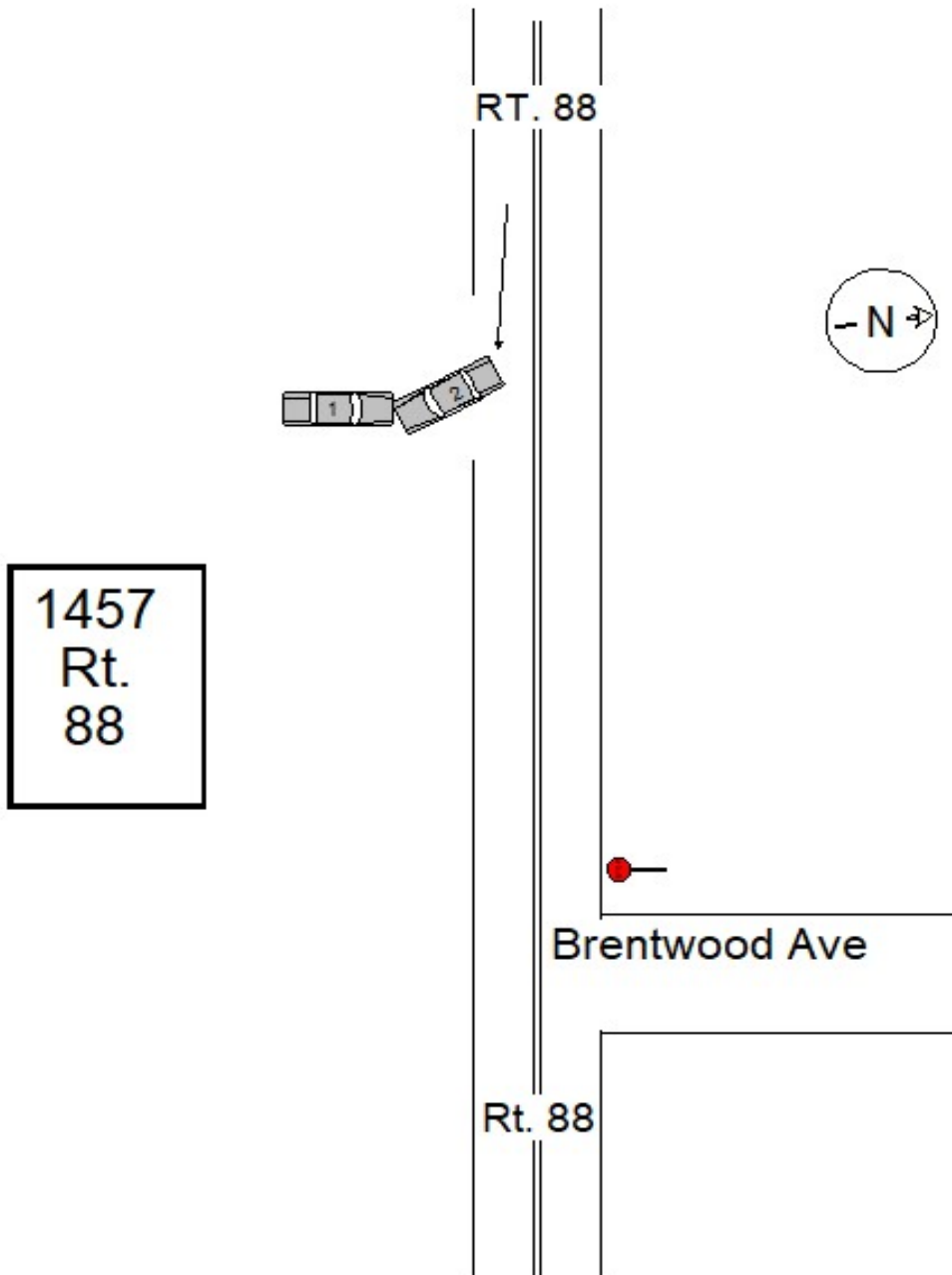
