135 Crash Description

Vehicle #2 parked unoccupied in Laurel Square Plaza, located at 1930 Rt 88. Vehicle #2 is parked improperly by encroaching into adjacent parking space. Vehicle #1 pulls into parking space and collides into rear of vehicle #2.

Owner of vehicle #2 stated she spoke with driver #1. Driver #1 stated she didn't cause any damage to vehicle #2. Owner of vehicle #2 advised driver #1 she contacted the Brick Township Police Department. Driver #1 then flees area westbound on Rt 88. Minor damage on vehicle #2 consisting of a small scratch on the rear bumper. Unable to locate vehicle #1. Owner of vehicle #2 described driver #1 as a white female with brown hair, approximately 40 years of age.

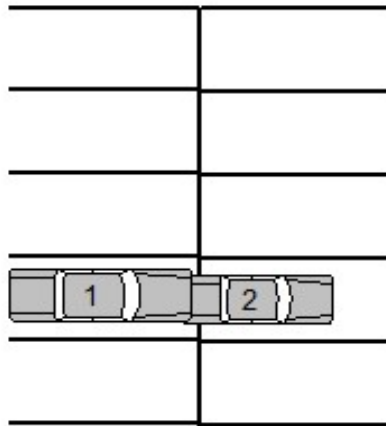
