135 Crash Description

-Veh #1 was backing out of a parking space, traveling north, in the parking lot of 1890 Rt. 88. Veh #2 was parked facing west in the lane of traffic, behind Veh #1. Driver of Veh #2, Beth Cox, stated that she parked Veh #2 in the lane of traffic to move a shopping cart out of the parking space which she was going to pull into. Cox stated that when she exited Veh #2, she saw Veh #1 back out and strike Veh #2, causing the collision. Driver #1 stated that she did not see Veh #2 parked behind her.

-Witness, JoAnne Ganley (732-642-9618) stated that she witnessed Veh #1 back up in Veh #2, causing the collision.

-No injuries reported at the scene.

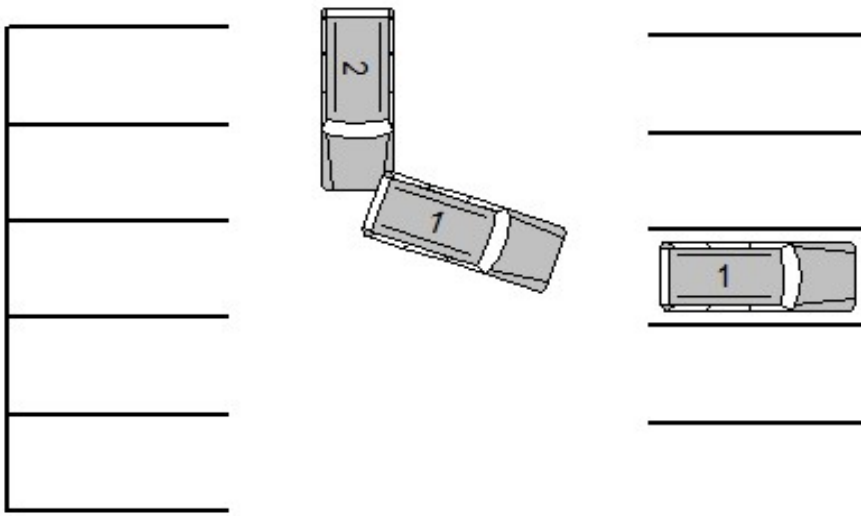
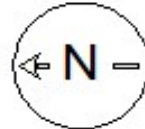
