135 Crash Description

Vehicle 1 began to slow down while heading east bound on Rt. 88, attempting to make a right hand turn into the parking lot of 1715 Rt. 88. Vehicle 2 was traveling east bound on Rt. 88 behind Vehicle 1. Driver of Vehicle 1 stated he did use his turn signal prior to making the turn. Driver 1 stated he heard a loud screech behind him and observed vehicle 2 approaching the rear of his vehicle at a high rate of speed while applying it's breaks and skidding in the roadway. Driver 1 stated Vehicle 2 did not contact his vehicle at that time, however that Driver 2 began screaming obscenities out her window at him to get out of the road way. Driver 1 stated that Vehicle 2 attempted to go around him in traffic, crossing over the double yellow lines into oncoming traffic. Driver 1 stated that in attempting to do this, the front passenger fender and passenger side rear view mirror of Vehicle 2 came into contact with the rear driver side bumper and tail light of Vehicle 1. Driver 1 stated Driver 2 stopped briefly after the impact and again began yelling at him before pulling away. Driver 1 stated he pulled into the parking lot to observe the damage to his vehicle when Vehicle 2 returned to the scene. Driver 1 stated that Driver 2 exited her vehicle and began threatening him so he would not call the police. Driver 1 stated that Driver 2 went into the roadway and removed debris from the accident, including her passenger side mirror which was removed during the impact, and placed it back into her car after stating "I'll hit you in the fucking face with this mirror if you call the cops." Driver 1 stated that Driver 2 then returned to her vehicle and fled the scene, continuing east bound on Rt. 88. Driver 1 described Vehicle 2 as a late 90's model 4 door silver Honda. He described Driver 2 as a white heavy set female mid to late 20's with shoulder length blonde hair. He stated he believed the first three letters of the vehicle NJ registration were YVJ.

At approximately 1430 hours that day, Driver 2 responded to headquarters to report the accident. I obtained her license and vehicle information and observed damage to her car, which consisted of a broken passenger side view mirror and scratch/scuff marks along the rear passenger door and rear passenger fender. She stated she had left the scene because Driver 1 had become extremely hostile towards her and she did not feel safe. She stated she waited so long to report the accident because she was not able to get out of work until her lunch break. Driver 2 stated she may have been following Vehicle 1 too closely when he stopped short to turn into the parking lot with out the use of his turn signal.

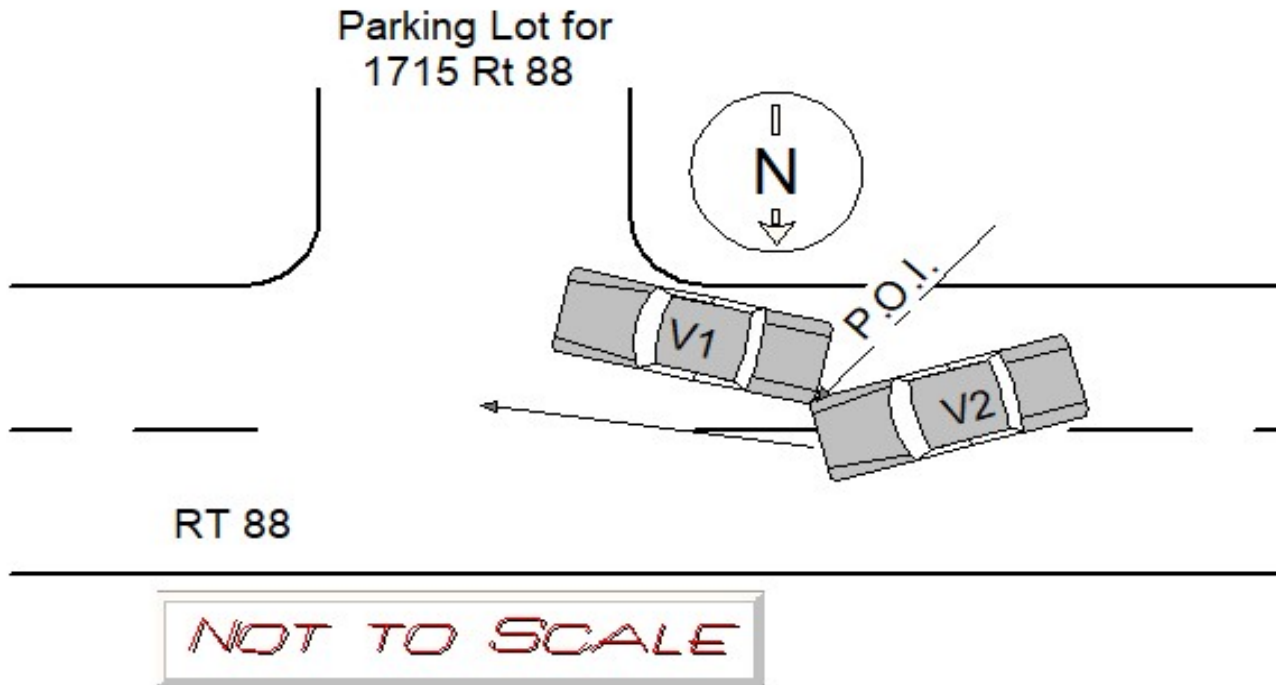
