Vehicle 1 driver states he then moved his vehicle to a different area of the parking lot because he felt the parking space was too tight. He states his radio was on and he did not realize he struck vehicle 2. Two witnesses contacted BTPDHQ about witnessing the crash. Both witnesses completed a witness statement form.

Motor Vehicle Crash Diagram

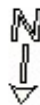

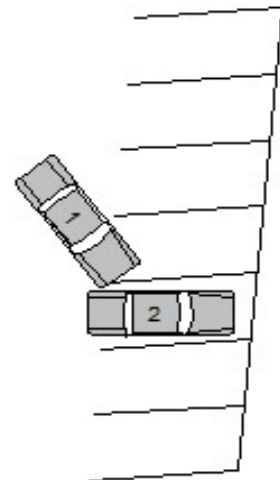
