135 Crash Description

Vehicle 2 was parked properly, with the front of the vehicle facing in, within a designated parking space in the parking lot of 1930 Rt. 88 (K-Mart), not running and unoccupied. Vehicle 1 attempted to make a right turn into the parking space on the passenger side of Vehicle 2. Driver of Vehicle 1 stated he misjudged the turn and took it too wide while attempting to park, causing the front lower driver side of his vehicle to strike the lower rear passenger side of Vehicle 2, causing minor damage. Vehicle 1 was moved into a parking space prior to my arrival on scene.

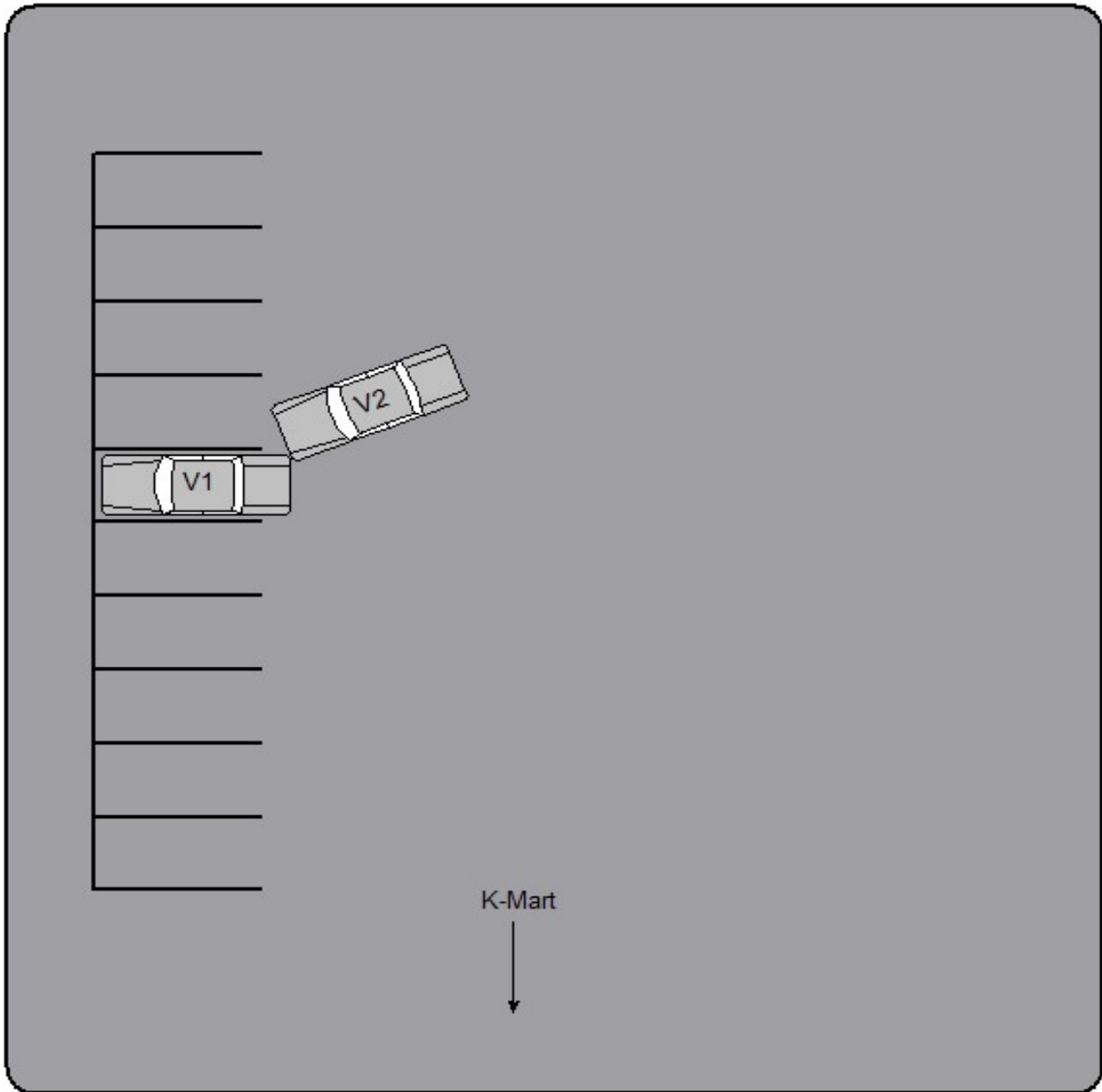
