135 Crash Description

Veh #1 was traveling east bound on Rt. 88, approximately 100 ft. east of Edge St. going straight ahead. Veh #2 was stopped in the parking lot of 1651 Rt. 88, waiting to back out onto Rt. 88. Veh #1 crossed over the solid white line into the shoulder lane and struck Veh #2. Witness Ryan Griffin (732-664-1899) stated that he was traveling directly behind Veh #1 and witnessed the collision. Griffin stated that he saw Veh #1 cross into the shoulder lane and strike Veh #2. Griffin stated Veh #2 was not backing at the time of the collision. Driver #1 stated that he was unaware that he struck Veh #2, until Driver #2 stopped him several miles away and advised him. Passenger in Veh #2 had complaint of pain to his back and was transported to Brick Hospital by Brick EMS. No other injuries reported at the scene. Driver #1 was issued the following summons: 39:4-88 failure to maintain lane, T-090927 and 39:3-4 unregistered vehicle, T-090926. Driver #2 was issued a summons for 39:3-4 unregistered vehicle, T-090925.

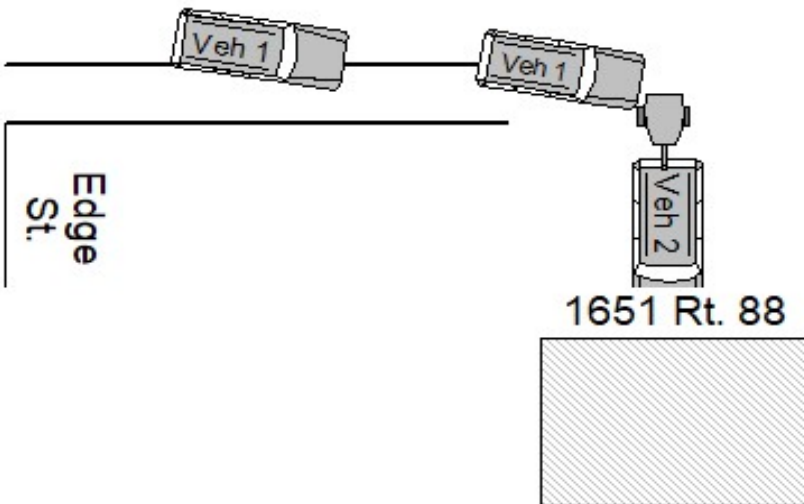
