145. Crash Description/Narrative

On 05/09/2021 at 1440 hours Ptl. Newlund #285 and I (Ptl. Rackliffe #309) responded to 55 Brick Blvd. (Stop N Shop) for a report of a hit and run. We were advised that the complainant (who was later identified as Chad Shedlebower) was waiting by his Blue Yukon, which was parked in a parking spot in front of the Stop N Shop.

Upon arrival we identified the Blue Yukon, which was bearing NJ registration (V24-HCX). I immediately observed that there was minor damage to the right upper rear side of the vehicle. The unknown vehicle, that left the scene, struck the parked unoccupied Yukon on the right upper rear bumper. The paint transfer on the Blue Yukon was not significant enough to make out what color vehicle had struck the Yukon.

In speaking with Shedlebower, he advised me that he was inside the Stop N Shop for approximately an hour and a half. Shedlebower further explained that when he approached his vehicle, after exiting Stop N Shop, he discovered that someone had placed duck tape over the damage. Shedlebower does not recall the vehicle that may have been parked next to him.

I observed that the Stop N Shop had exterior cameras which covered the area of the parking lot that the incident

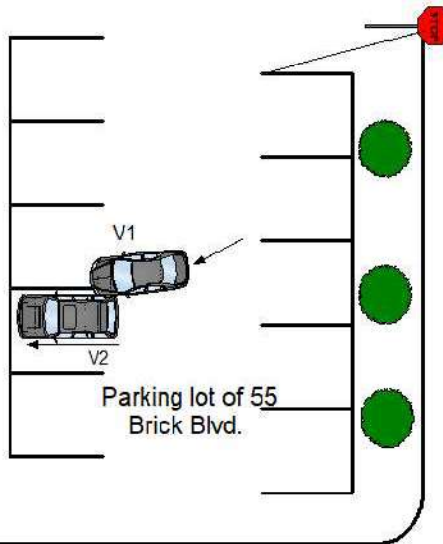
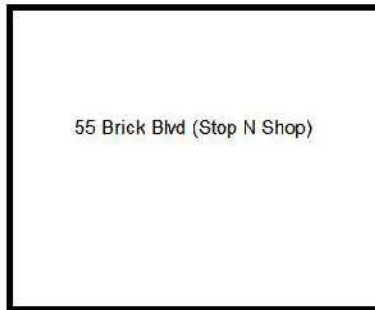

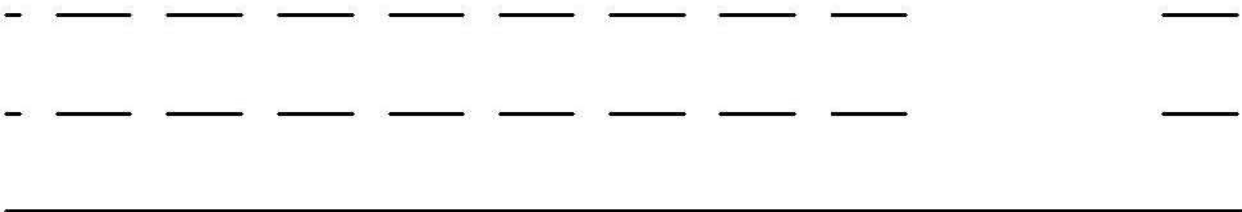
