145. Crash Description/Narrative

Vehicle 1 traveling north on Herbertsville road was making a left turn onto Lanes Mill Road. Vehicle 1 turned in front of vehicle 2 which was traveling south on Herbertsville road straight through the intersection. Vehicle 2 struck vehicle 1 as a result while traveling through the intersection.

Driver 1 stated he was traveling north on Herbertsville Road and attempting to make a left turn onto Lanes Mill Road. Driver 1 believed he had enough time to turn in front of vehicle 2 but stated as he was turning he realized he did not. Driver 1 stated he did not think vehicle 2 was slowing down and that he attempted to speed up to get through the intersection when vehicle 2 struck the rear passenger side of his vehicle. Driver 1 complained of chest pain and was transported to Ocean Medical Center.

Driver 2 stated she was traveling south on Herbertsville Road approaching Lanes Mill Road when vehicle 1 turned in front of her. Driver 2 stated she did not have enough time to stop and subsequently struck the rear passenger side of vehicle 1. Driver 2 complained of chest pain but she refused medical attention.

Investigation revealed that the cause of the crash was due to driver 1 failing to observe the close proximity of

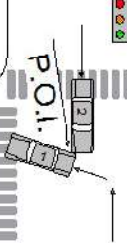
