145. Crash Description/Narrative

On 12/1/2017 at 1035hrs, Michael Guarino owner of 214 Brick Blvd- Michael's Furniture contacted Hq in reference to the carting truck that caused damage. Guarino stated when he arrived this morning he observed damage to the lighted signs on the south side of the building. He observed on video at 0646hrs this morning Roselle Suburban Disposal truck pulling into the parking lot. At 0648hrs the truck was in the rear of the building emptying the containers. Tire tracks are observed in the front lot tight to the building heading towards the rear. Guarino contacted Roselle Suburban Disposal several times with negative results.

By 1630hrs I left 2 detailed messages with Roselle Suburban Disposal with negative results.

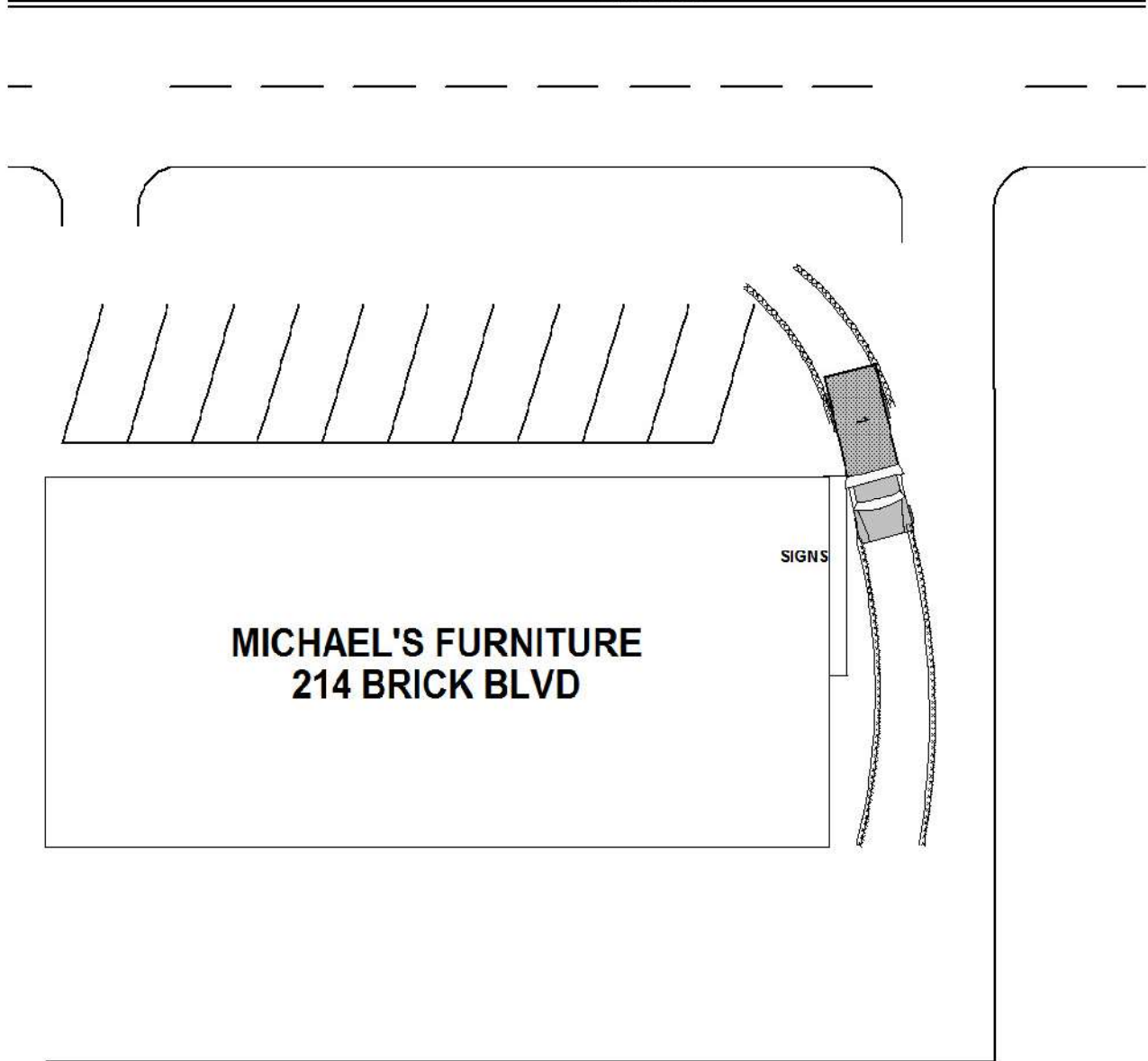
