145. Crash Description/Narrative

Investigation at the scene revealed the following: Vehicle #2 was traveling westbound in the parking lot of Staples at 495 RT 70 on the access road by the Houlihan's restaurant. Vehicle #1 was traveling northbound in the parking lot of Staples, approaching the access road. Vehicle #1 stopped at the stop sign, but failed to yield to the right of way of Vehicle #2. Vehicle #1 turned left into Vehicle #2's lane of travel, and struck the left rear of Vehicle #2 with the front right of the vehicle. Vehicle #2's right rear side then slid in a counter clockwise direction, and struck the curbed island with the right rear wheel. Vehicle #2 proceeded forward approximately fifteen feet and came to rest. Vehicle #1 continued to go forward, and came to rest on the curbed island.

Driver #2 stated he was traveling westbound in the parking lot, and he observed Vehicle #1 drive into his lane of travel. Driver #2 stated Vehicle #1 struck the left rear of his vehicle. Driver #2 stated the force of the impact caused the right rear of his vehicle to slide and struck the curbed island.

Driver #1 stated she was stopped at a stop sign in the parking lot facing northbound. Driver #1 stated she observed Vehicle #2 traveling westbound, and made a left entering Vehicle #1's lane of travel. Driver #1 stated

145 Crash Description

Vehicle #2 sped up, and she subsequently struck the left rear of Vehicle #2 with the front right of her vehicle, and proceeded forward onto the curbed island.

Driver #1 had the odor of an alcoholic beverage emanating from her breath. Driver #1 admitted to consuming a glass of wine earlier in the day, but passed field sobriety tests.

Both vehicles were not moved prior to my arrival. Driver #1 had complaint of wrist pain, and had a small abrasion to the left hand. Driver #1 was treated by Brick Township EMS #M537, and refused further medical treatment. Driver #2 had no reports of injuries on scene.

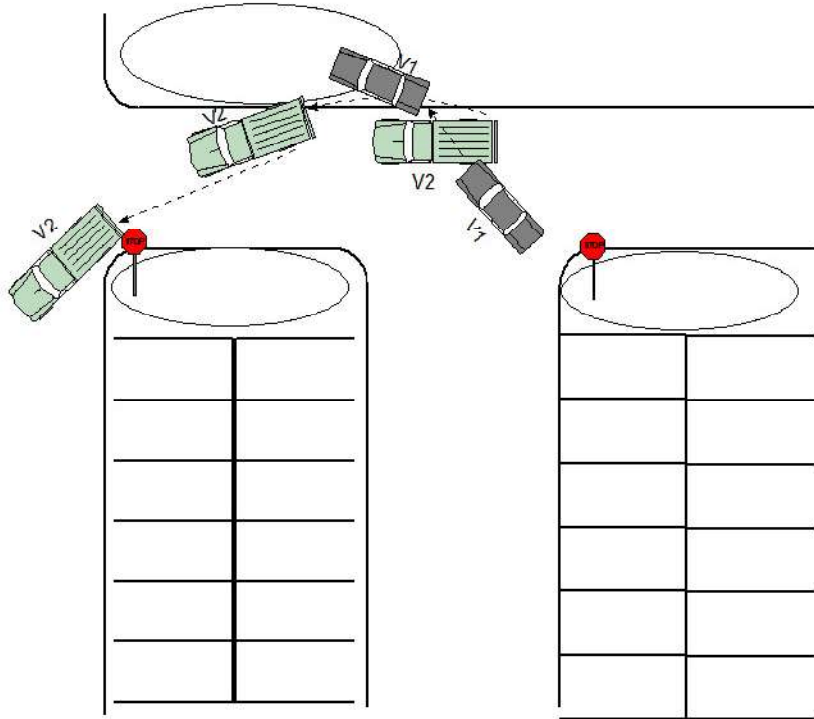
